However, the subject has some peeling paint on the exterior, which appears to be in need of repair. There was a construction dumpster in the driveway of the home at time of inspection. No exterior construction was visible. When searching for comps, the distance searched was 1 Mile and the time searched was 6 Months time. Sold comps were searched for slightly beyond 3 Months Time to locate properties similar in GLA and other attributes. In order to support the subject GLA, and to avoid searching further in distance from the subject, one superior condition comp was used with adjustments. Market conditions and property values are improving within this area. The subject bedroom and bathroom count has been estimated, as it is not available on tax records. The subject did not appear to have any negative site influences.</p>

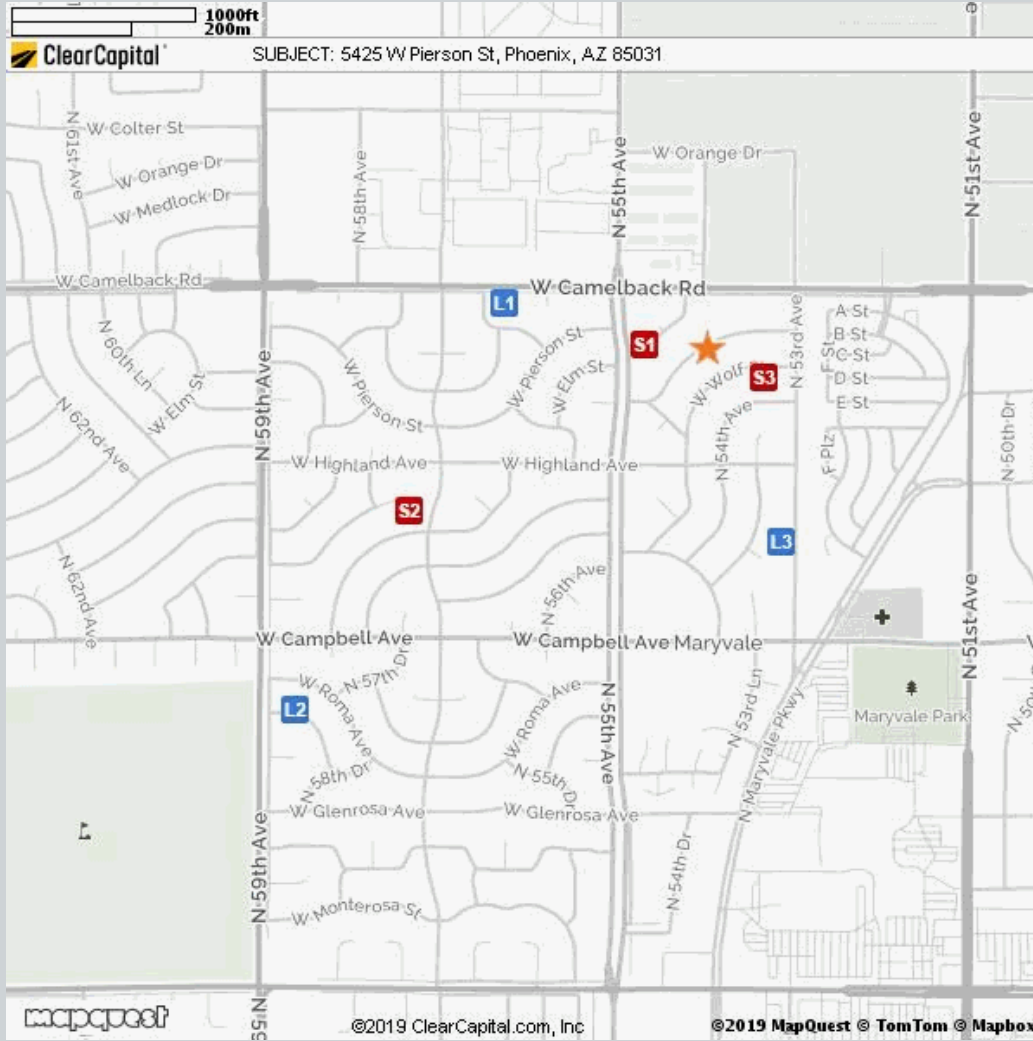
