Comments Regarding Pricing Strategy		
<p>The subject property is a single family home, which is in overall average condition on the exterior. When searching for comps, the distance searched was 1.25 Miles and the time searched was 6 Months time. Comps were searched for beyond 1 Mile to locate properties similar in GLA and other attributes. Sold comps were searched for beyond 3 Months Time as there was a lack of comps to support the subject's GLA in this area. Since the subject is in average condition, emphasis was placed on using comps which were also in average condition. The market area has many recently remodeled or significantly updated homes, which were excluded from use in this report, because they are not most representative of the subject. However, it was necessary to use one superior condition comp with adjustments due to the limited similar comps in this area. Market conditions and property values are improving within this area. The subject property did not appear to have any negative site influences within the immediate area. The subject's bedroom and bathroom count has been estimated, as it is not available in tax records. The subject's sale price was bracketed within the adjusted range of comp values, but not within the un-adjusted range, because all of the sold comps had concessions which needed to be adjusted for.</p>

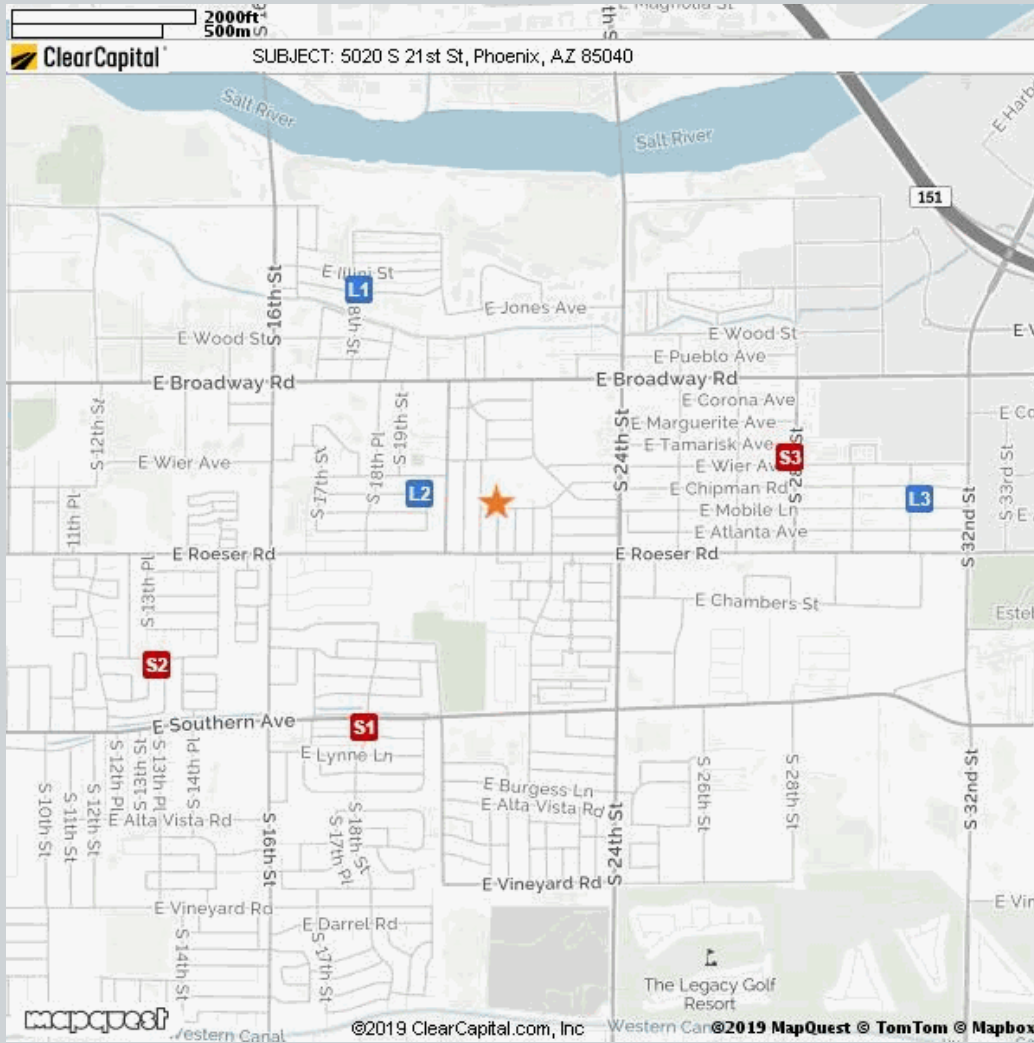
