- Sold 1** There is a lack of sale comps close to the subject's features, therefore I had to include comp over 0.5 miles far from the subject property with inferior unit number (\$10,000), superior year built (-\$10,500), but superior bed count (-\$8000), superior bath count (-\$8000).
- Sold 2** There is a lack of sale comps close to the subject's features, therefore I had to include comp over 0.5 miles far from the subject property with superior year built (\$6000), but inferior GLA (\$11,000), inferior bed count (\$5000).
- Sold 3** There is a lack of sale comps close to the subject's features, therefore I had to include comp over 0.5 miles far from the subject property with superior GLA (-\$13,000), superior bed count (-\$5000), superior year built (-\$3000).

Based on my exterior inspection of the subject property, I was not able to determine any damages. The interior condition of the subject is not determined as this was an exterior inspection. Value is based on the assumption that the subject has the characteristics in the report, and this information is based on the tax record information. Comparison analysis was done by collecting market data, selecting the most appropriate comparable properties, verifying market data, applying appropriate adjustments, and reconciling the various adjusted indicators of value into a value estimate. The sale value is based more on sold comps. All comps were the closest possible to subject in lot size, sq ft. I used MLS and tax record, I was not able to find better sold and active comps; therefore I include comps over 0.5 miles far from the subject property with inferior and superior features.</p>

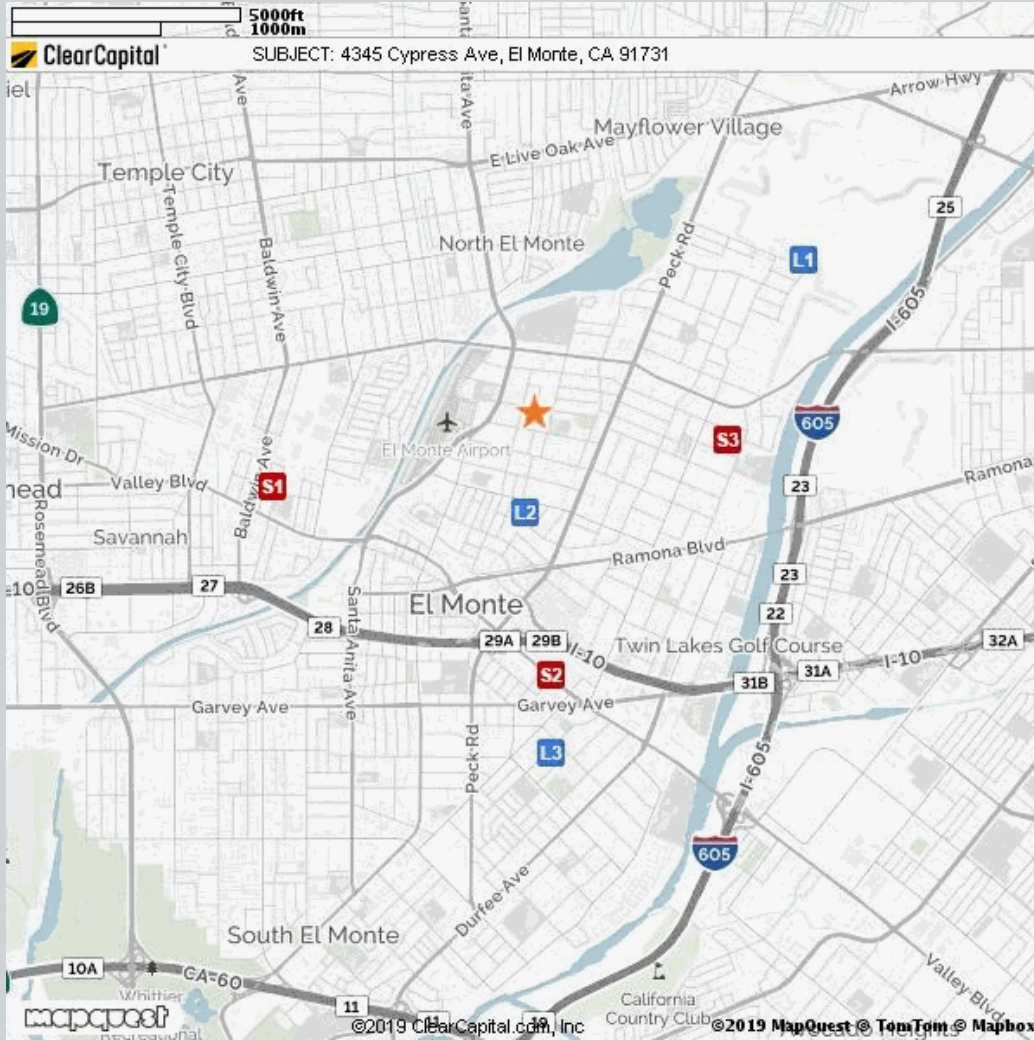
