Due to limited comparables, need to exceed proximity up to 1.8 miles, sold date up to 12 months, bed/bath count, lot size and year built over 30 years guidelines. Subject is unique in lot size and full bath count. Due to limited comps in the area, active comps were used despite not bracketing the GLA as they are still considered to be reliable comparables. In order to support the subject's GLA, it was necessary to use comparable that differed from the subject's style. Subject is located near busy road, highway, school, park, railroad and commercial amenities. Due to limited comparable from same location, it was necessary to use comparables from across the busy road. However, this won't affect the market value. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS3 and LC1 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. 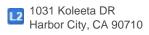

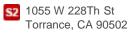

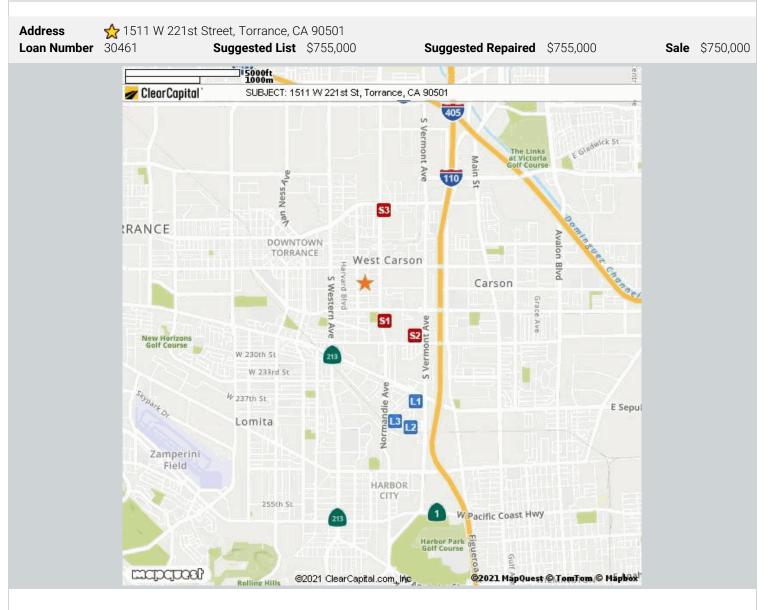
