Comments Regarding Pricing Strategy

There is very little inventory currently on the market or that has recently closed escrow. Due to the lack of inventory, I expanded distance (radius of 1 mile), lot size and square footage (+/- 20%), in order to find comps that were somewhat similar to the subject. The comps that I have used are the best available and have been taken from similar type areas. Value was determined by a comparison in age, lot size, square footage, location and condition of the properties. Median price in Sonoma County in July of 2019, was \$655,000, and in January of 2020, it was \$662,500, an increase of approximately 1%. On the Eastside of Petaluma, where the subject property is located, the median price in January of 2019, was \$620,000, and in January of 2020, it was \$675,000, an increase of approximately 9%.






