Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$1,245 due to sq ft, -\$1,150 due to the lot, \$1,000 due to age.

Comments Regarding Pricing Strategy

The search was extended back 4 months, out in distance 1 mile, and I was unable to find many comps which fit within 20% GLA requirements and similar style and appeal. Within 1 mile and back 4 months, I found 14 comps of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps. Listings: MLS #9302523/17402 Durham Ridge was considered but because this comp reflected a value very different than the rest of my comps, it was replaced with comps that better supported the market and my final value conclusion. Upon review of all pertinent information, an opinion of the 'as- is' market value of \$178,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspections, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.


