An attempt to find all sales and listings in a similar condition to the subject was made. However, due to the lack of comps, this was not possible. Please note due to lack of comps some lot size tolerances were exceeded as well as some distance parameters were expanded. The subject is on the city sewer. The search criteria were set to a one-mile radius search (preferably using comps in the same subdivision when available) for comps within 5 years of age +/- and 20% sqft +/-. When this was not available the The search radius was expanded. Please note there is an airport in the area. There is no adjustment as the comps are in the same area. Many of the homes in the area are being torn down and new homes are being built on their lots. Due to this and lack of comps there are large variances in value.\*\*\*Please note based on information provided to me the subject sold on 2019-10-09 at a price of \$308,000 This sale is not listed in MLS or any of the secondary sites. I do see on the tax records (attached) there was a change of ownership. However, TX is a nondisclosure state so I can not say that number is accurate. This sale could not be entered into the grid above due to a lack of information. I don't know the list price, list date, pending date..... If I placed the information that was given to in the grid I would not be able to submit the form. If this price is accurate the subject likely has interior damage. This could not be seen from the exterior. This explains the difference in value. My assumption is the subject is in average condition. No average comps support the value of \$308K


