Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and a smaller lot. Overall, similar in design and appeal and has comparable views. Adjustments: \$3255 due to sq ft, \$1869 due to the lot, -\$400 due to age, -\$1500 due to room count, -\$5,000 due to updates.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$1515 due to sq ft, \$2522 due to the lot, \$800 due to age, -\$10,000 due to updates.
- Sold 3** It also has the same view as the subject, but its updates make this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: \$1022 due to the lot, -\$20,000 due to updates.

<p>The search was extended back 6 months, out in distance 1 mile, and even with relaxing 35% GLA search criteria I was unable to find many comps that fit within 20% GLA requirements and similar style and appeal. Within 1 mile and back 6 months, I found 19 comps of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps. The comps below were considered but because they reflected a value very different than the rest of my comps, they were replaced with comps that better supported the market and my final value conclusion. Listings: MLS #47750419/ 17422 Crows Nest Listings: MLS #55473077/17222 Golf Club Listings: MLS #33452063/ 713 Foley Rd Listings: MLS #24724477/ 17318 Marlin Spike Way Upon review of all the pertinent information, an opinion of the as-is market value of \$172,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.</p>

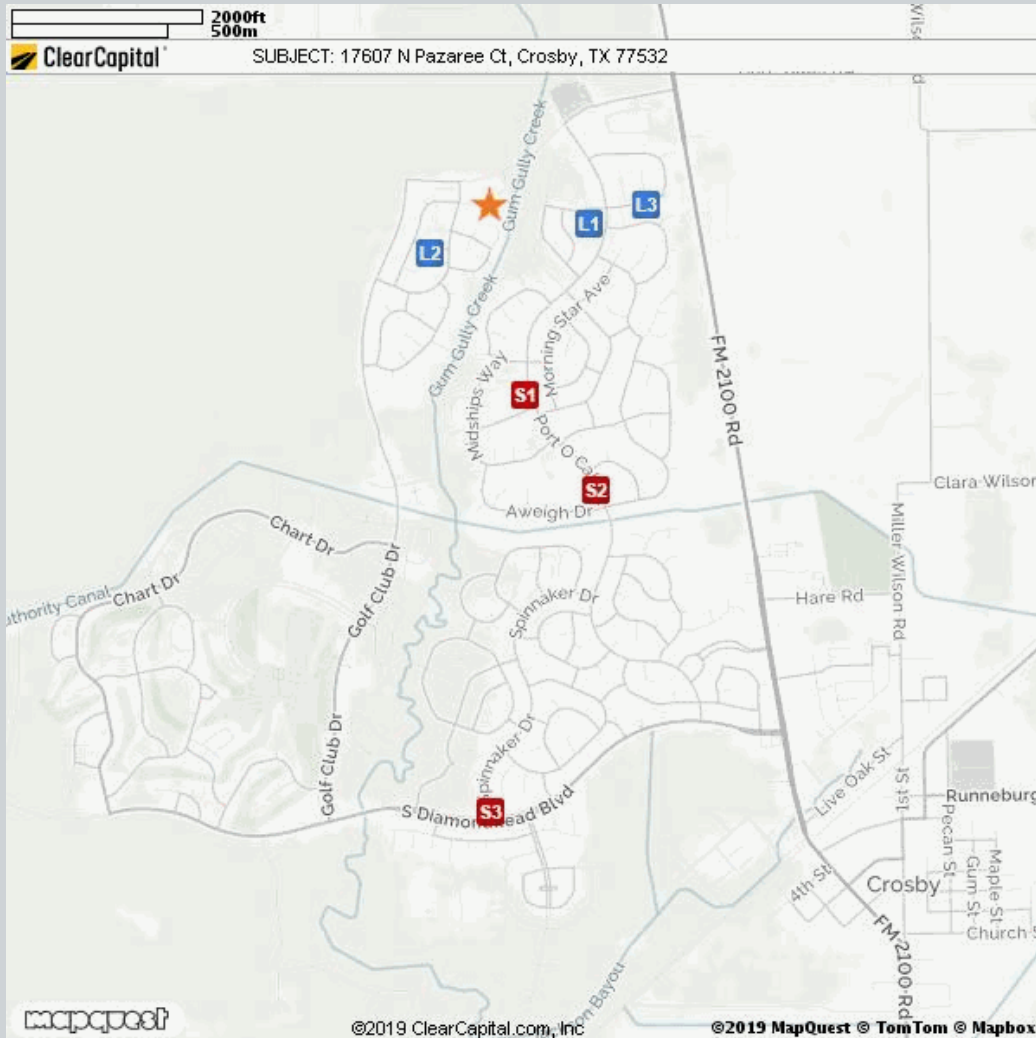
