Went back 1 mile and four months to locate appropriate comps. Comps used are the best available and the adjustments are sufficient for this area to account for the differences in the subject and comps. Overall economic and residential market trends are stable. Property values in the area are stable with slight increases. REO properties comprise 1% of this market.</p>

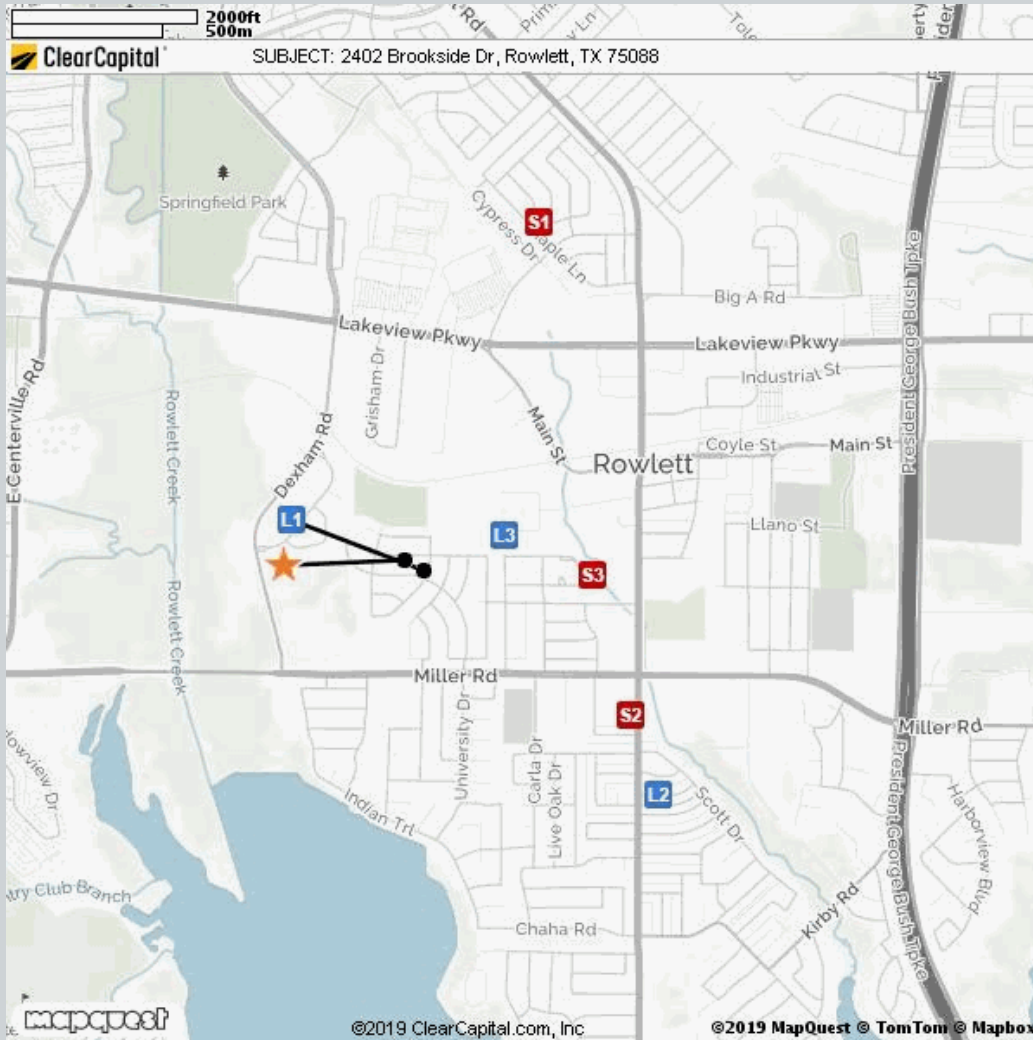
