### Comments Regarding Pricing Strategy

Subject is a single family home with 2186 Sq.ft. Since there were limited comparable available within subject's market neighborhood, it was necessary to use a sold comparable with a sale date beyond 3 months from the date of this report. Due to limited comparables, need to exceed sold date up to 6 months, bed/bath count, lot size and year built guidelines. In order to support the subject's GLA, it was necessary to use comparable that differed from the subject's style. Due to limited comps in the area, sold comps were used despite not bracketing the GLA as they are still considered to be reliable comparables. Subject is located near busy road, highway, school, park and commercial amenities. Comparables are also from similar location and it support subject value and marketability. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS3 and LC2 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. Subject and comparables garage count is verified using MLS.

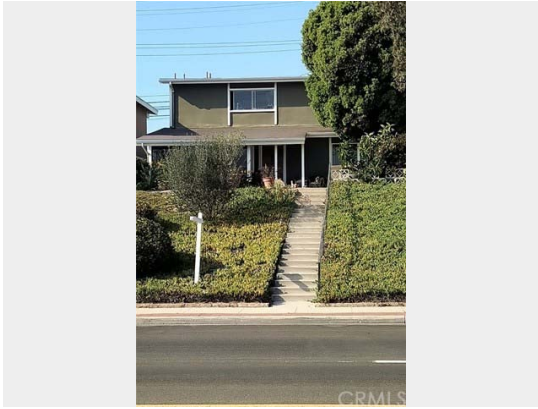

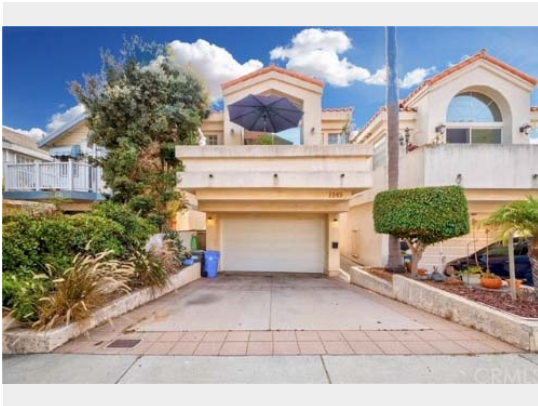

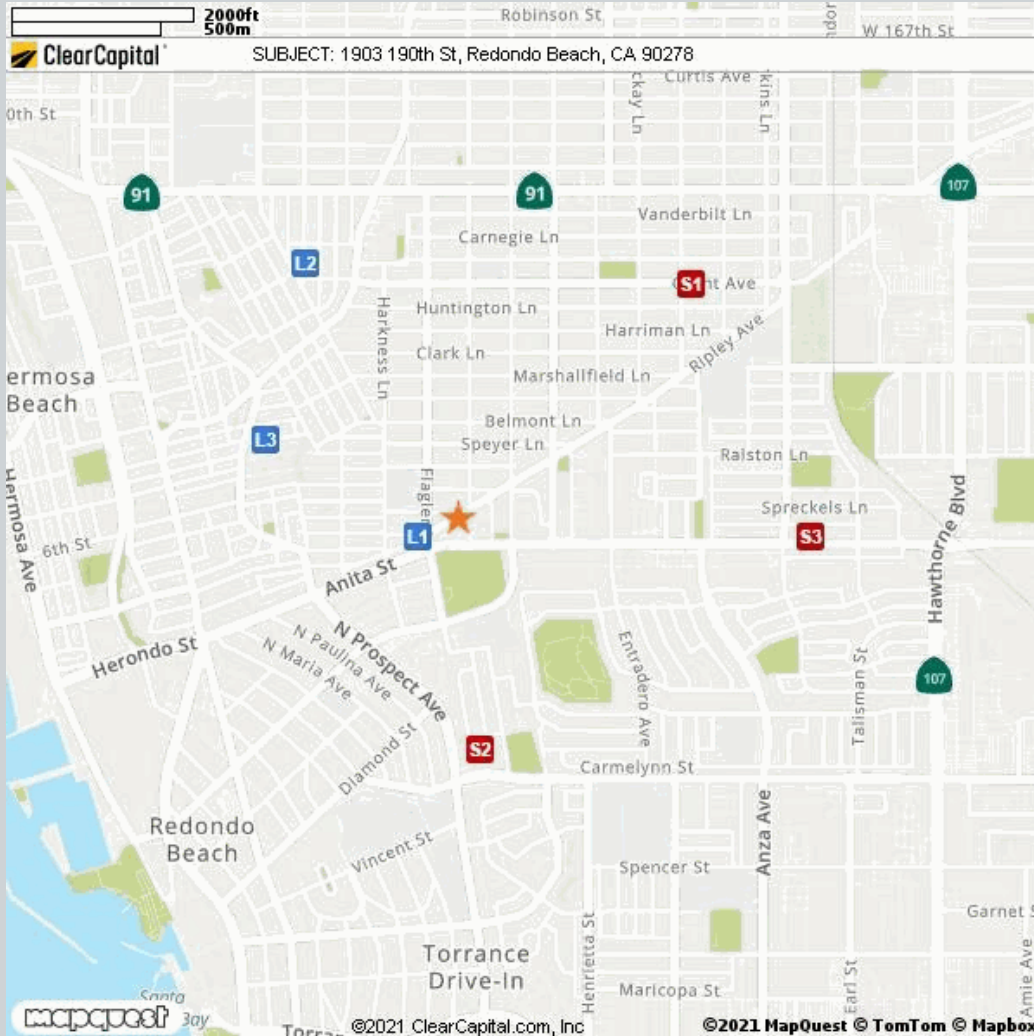
