<p>Properties in this neighborhood typically sell in less than 30 days. It is common for listings to receive multiple offers during the listing period and sell above listing price. This resulted in a shortage of comps in subject's neighborhood. It was necessary to go outside of subject's immediate neighborhood and cross major boundaries to locate comps in subject's condition. Went back .8 miles and five months to locate appropriate comps. Comps used are the best available and the adjustments are sufficient for this area to account for the differences in the subject and comps. Overall economic and residential market trends are stable. Property values in the area are stable with slight increases. REO properties comprise 1% of this market.</p>

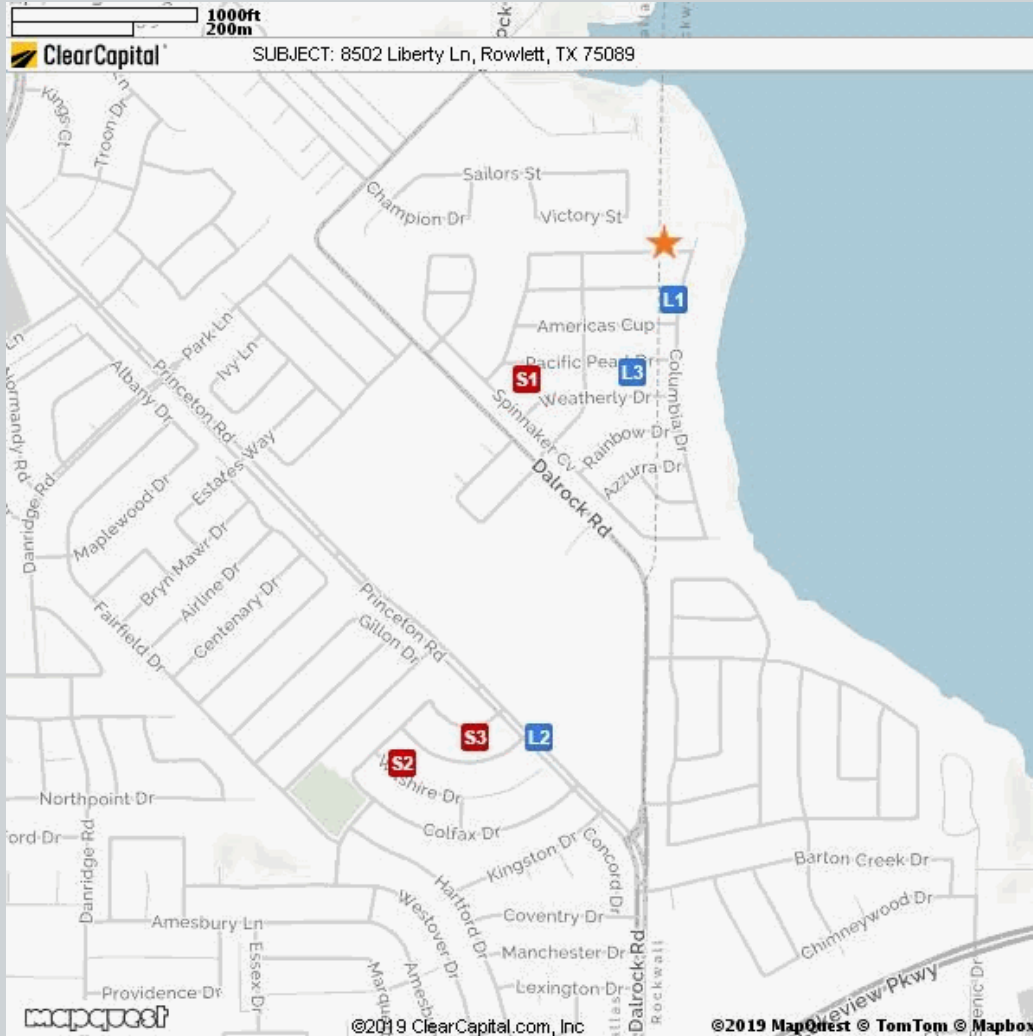
