A one mile radius search of detached homes was used.

EXPLANATION OF ADJUSTMENTS

8407 Olympic Blvd was proximately located to the subject and was adjusted for inferior appeal busy street location, superior newly remodeled condition. Comp 1 was adjusted for inferior GLA, #3 was adjusted for superior garage space. #2 and 3 were adjusted for superior appeal lot area.


ADDITIONAL COMMENTS (OPTIONAL)

Comp 3 appears to back to railroad tracks, but based on available data no negative location adjustment would be warranted or supportable. #1 exceeded 10% line item adjustment but included due to proximity and similar appeal lot area.

Reconciliation Summary

Most weight given to comp 1 due to close proximity and similar lot size. Least weight given to comp 3 as it was the least proximate to the subject.

Scope of Work

The purpose of this Appraisal Report is to determine an and the opinion of the market value for the subject property, at which it could sell in a typical exposure time for the area, considering current market conditions, the condition of the subject and necessary repairs.

SCOPE OF WORK:

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Francisco Ursulo, a licensed real estate agent having completed the above referenced Property Inspection.
