Comments Regarding Pricing Strategy

Subject recommended pricing is based on the best of the comparable properties in the immediate market area. Pricing is based on those comparables used in this report which are closer to the subject in proximity and most similar in terms of GLA, age, lot size, other features, and amenities. Search for comps was done using a 1-mile radius, 30% difference in gla, 25 years difference in age and a 180-day close date. Most of the comparables used in this report are inferior to the subject in terms of Lot size. Necessary adjustments are made to the final value in order to compensate for the variance. Comparables used in this report are the best available at the time of inspection and represent the immediate market scenario. Due to a lack of listing comparable properties in the area, it was necessary to use comps with variance in +/- 20 years, expanded back 180 days from the current date, +/- 30% of the subjects gla. Similar styles, also location and condition were considered due to limited comps in the immediate area.
