<p>Our market is currently stable- SFR saw a jump of 6% in sales price since this time last year, while condos/townhomes saw an increase of 8.9% in sales price. Demand remains strong with supply remaining tight; Inventory is just over a 2 month supply. Distressed sales remain low, accounting for only 1.8% of sales. Cash sales account for about 22% of recent sales. Days on market have increased slightly- roughly 71% of homes sell within 60 days. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only- interior condition could dramatically affect the value of the property.</p>

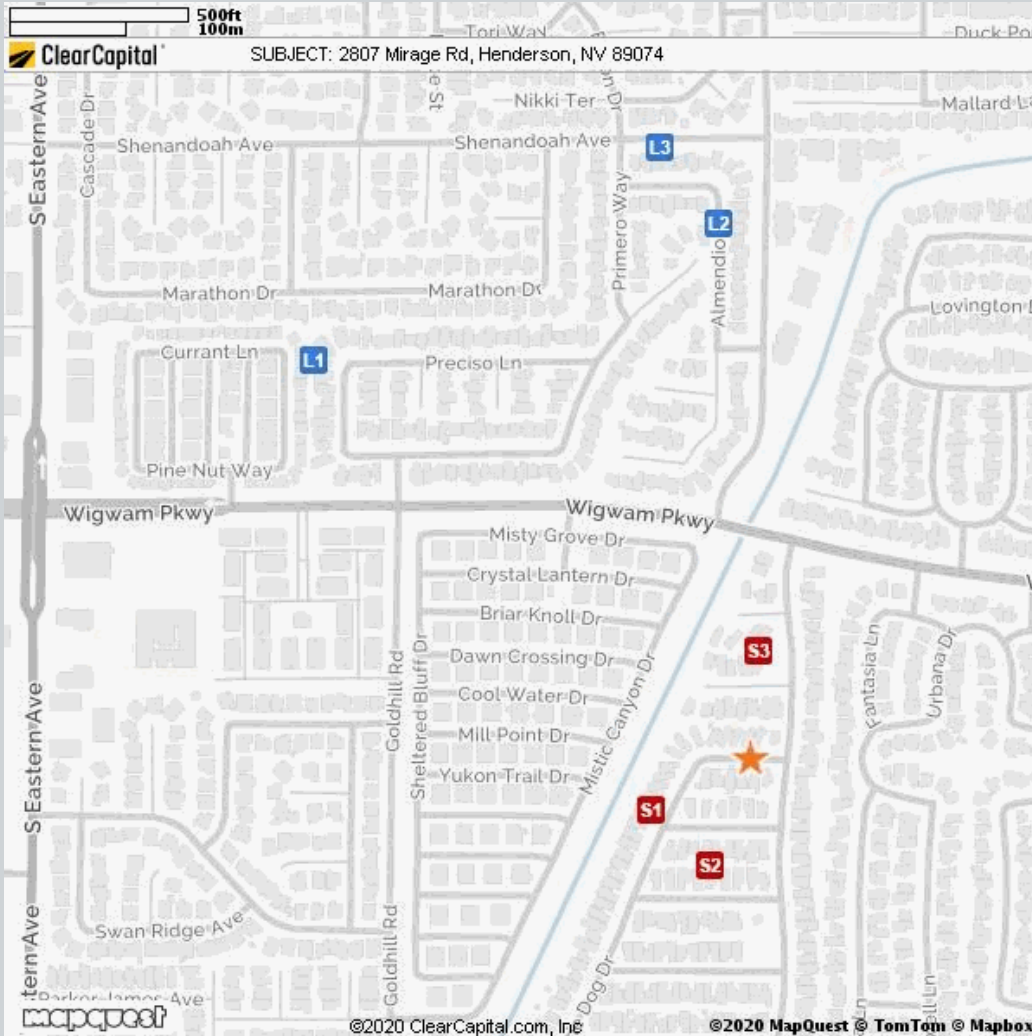
