<p>There are 8 active comps within a mile distance, 20% size and 20 years age of the subject. None are smaller than the subject. There was 1 sale in the last 3 months and 8 in the last 6 months within the same criteria. The market in this area is flat so far in 2020, was up 8% in 2019, was up 8% in 2018, was up 8% in 2017, was up 12% in 2016, was up 7% in 2015 and was up 6% in 2014 according to MLS statistics. Listings are down over 14% and sales are up 7% in volume in 2018 from 2017 according to MLS statistics. Seller concessions are not prevalent. REO and short sale listings and sales continue to decline. Area unemployment is 4% as of 11/2019.</p>

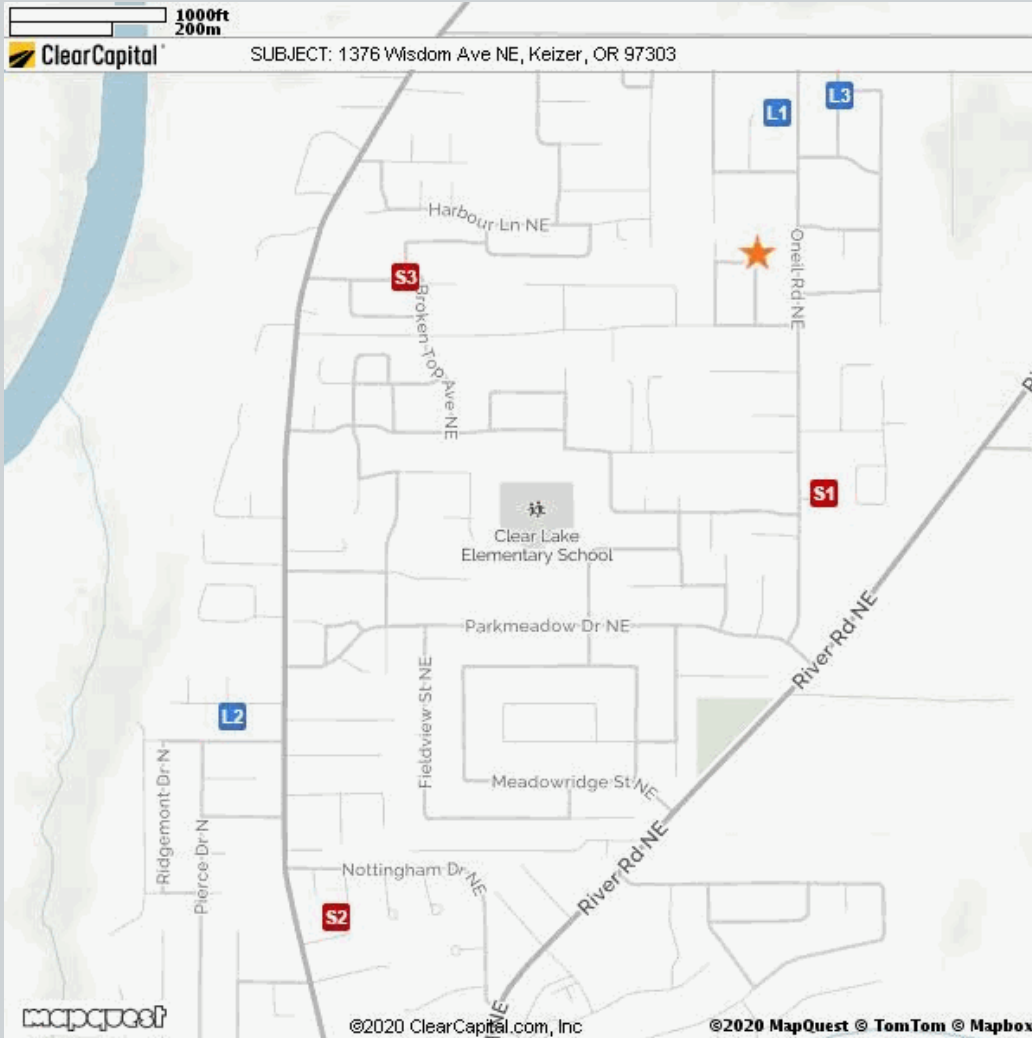
