Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of being an older building and for having a smaller lot. Overall, similar in design and appeal and has comparable views. Adjustments: -\$900 due to sq ft, \$1266 due to the lot, \$200 due to age, \$10,000 due to inferior updates.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$1380 due to sq ft, \$1905 due to the lot, \$800 due to age, \$3000 due to room count, -\$5000 due to 2-car garage.
- Sold 3** It also has the same view as the subject, but its larger room count and having superior updates makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: \$120 due to sq ft, -\$1155 due to the lot, \$800 due to age, -\$1500 due to room count, -\$5,000 due to superior updates.

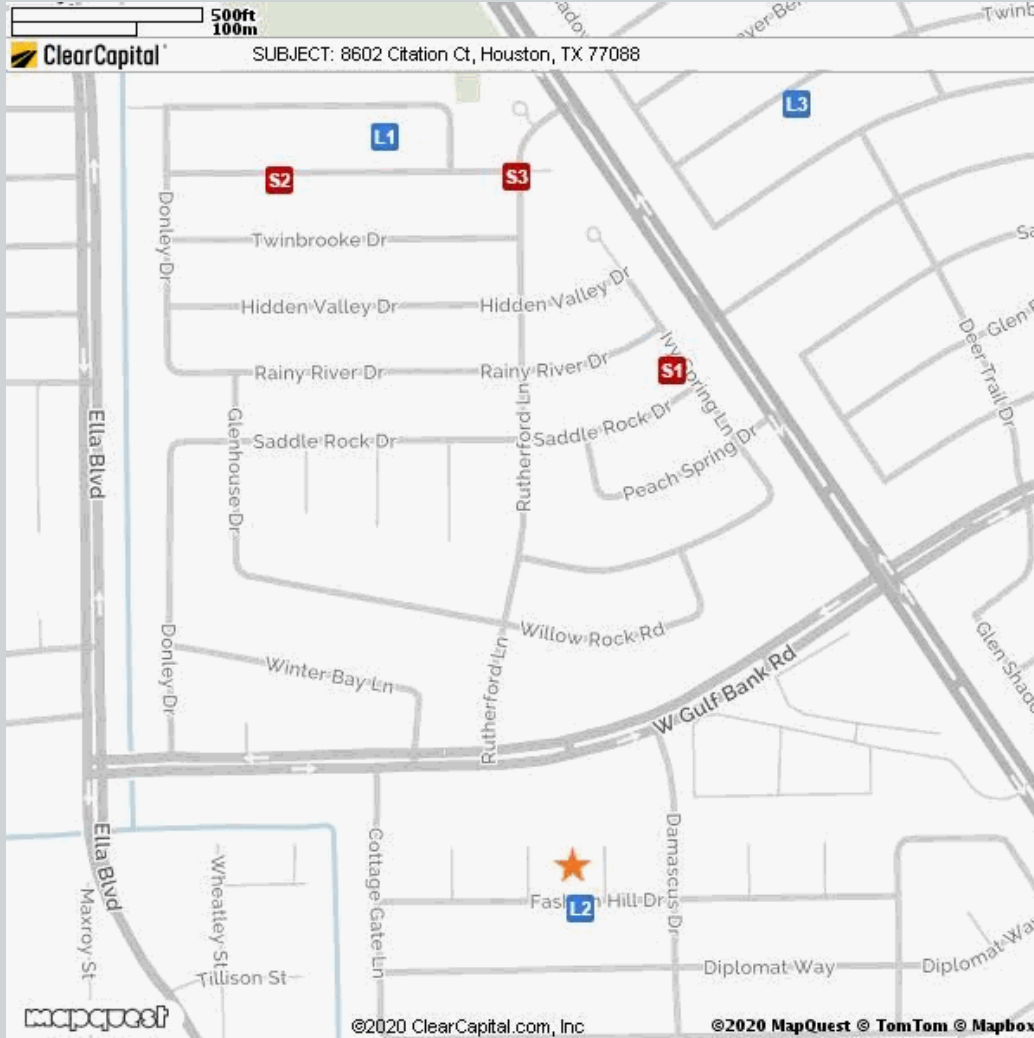
