In order to support the subject's GLA, it was necessary to use comparable that differed from the subject's style. DSubject is located near busy road, highway, school, park, golf course, railroad and commercial amenities. Due to limited comparable from same location, it was necessary to use comparables from across the RR track. However, this won't affect the market value. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS2 and LC1 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. Subject and comparables garage count is verified using MLS.</p>

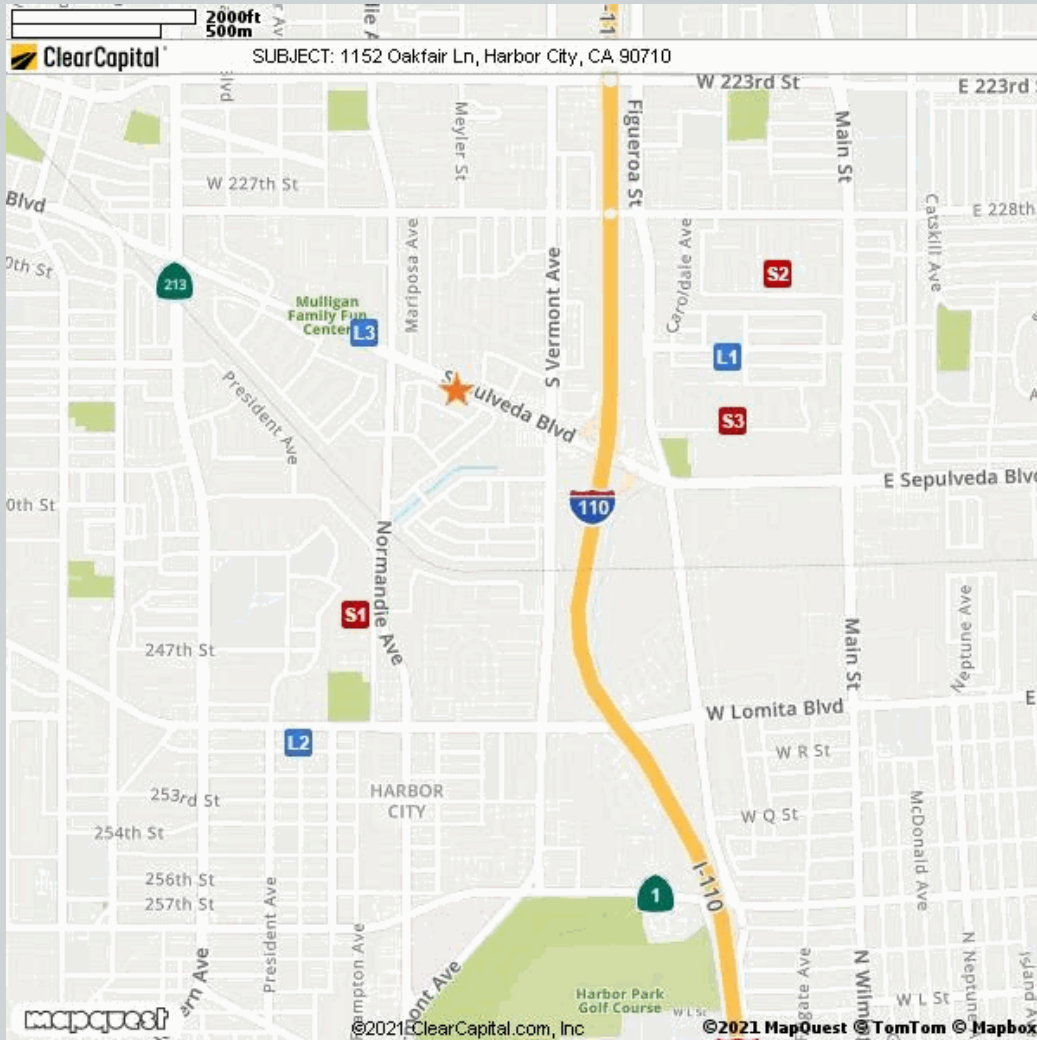
