- Sold 2** Sold with conventional financing, no concessions. Owner occupied property when listed. Identical in garage capacity, fireplace, no pool and age. It is inferior in condition \$30,000, baths \$2,500, but is superior in lot size adjusted @ \$2/square foot (\$15,700).

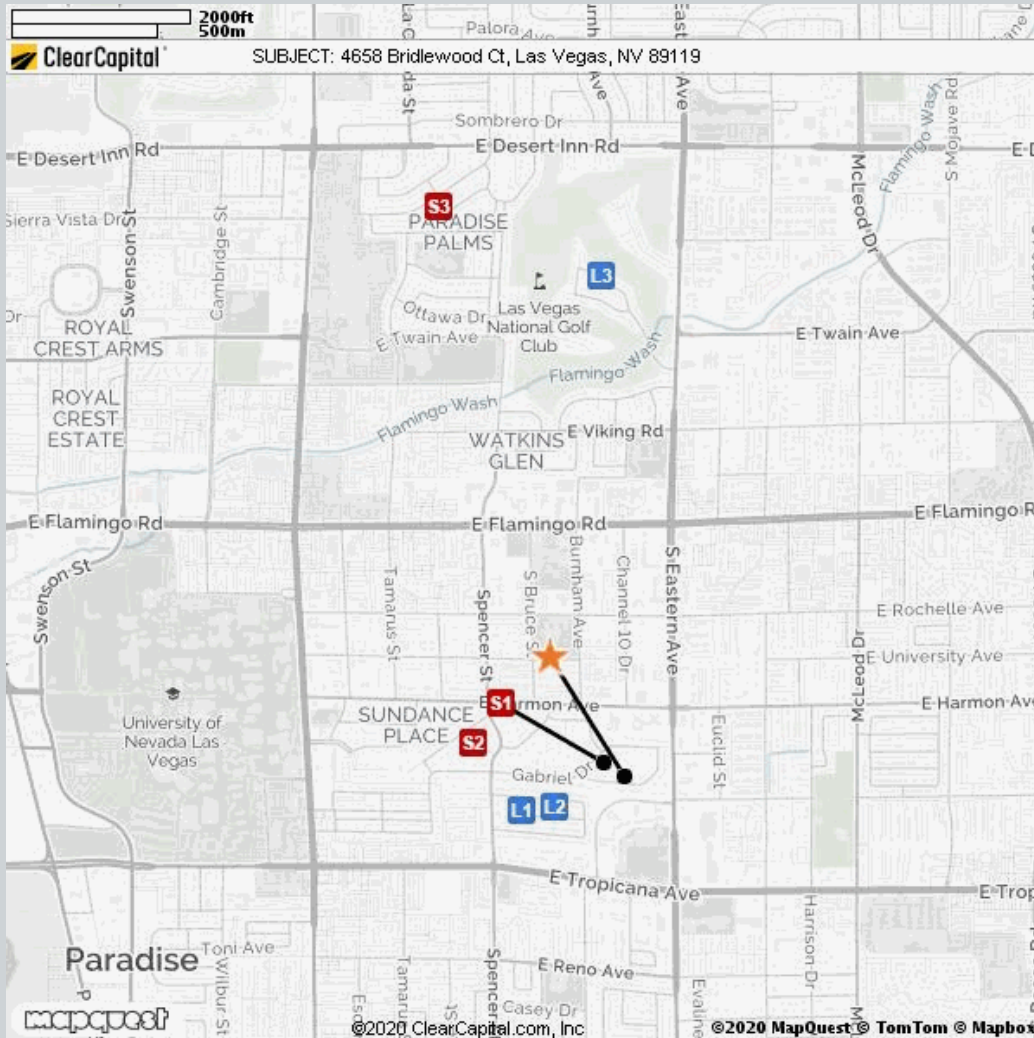
