<p>The subject property is a single- family. The subject was built in 2000 and is 1176 sq ft. Subject bed/bath count is not available in Tax record so I have estimated from the neighborhood. I have searched a distance up to 0.5 miles, gla +/- 20% sq ft, lot size 30% +/- sq ft, age 10% +/- yrs and up to 6 months in time. There were limited similar criteria comparable available. Therefore, I exceeded year built, GLA, bed/bath count and proximity guidelines up to 1.30 miles. Due to limited comps in the area, active comps were used despite not bracketing the year built and bath count as they are still considered to be reliable comparables. Due to limited comparable with similar criteria variance in bed/bath count comparable was used in this report. The subject is located near busy roads, schools, waterbody, highway, and commercial buildings. Active Comparable crossed the highway road. However this won't affect the market value. In delivering final valuation, the most weight has been placed on CS3 and LC2 as they are most similar to subject condition and overall structure</p>

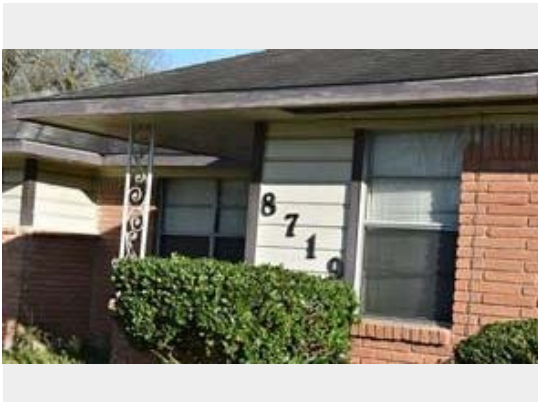

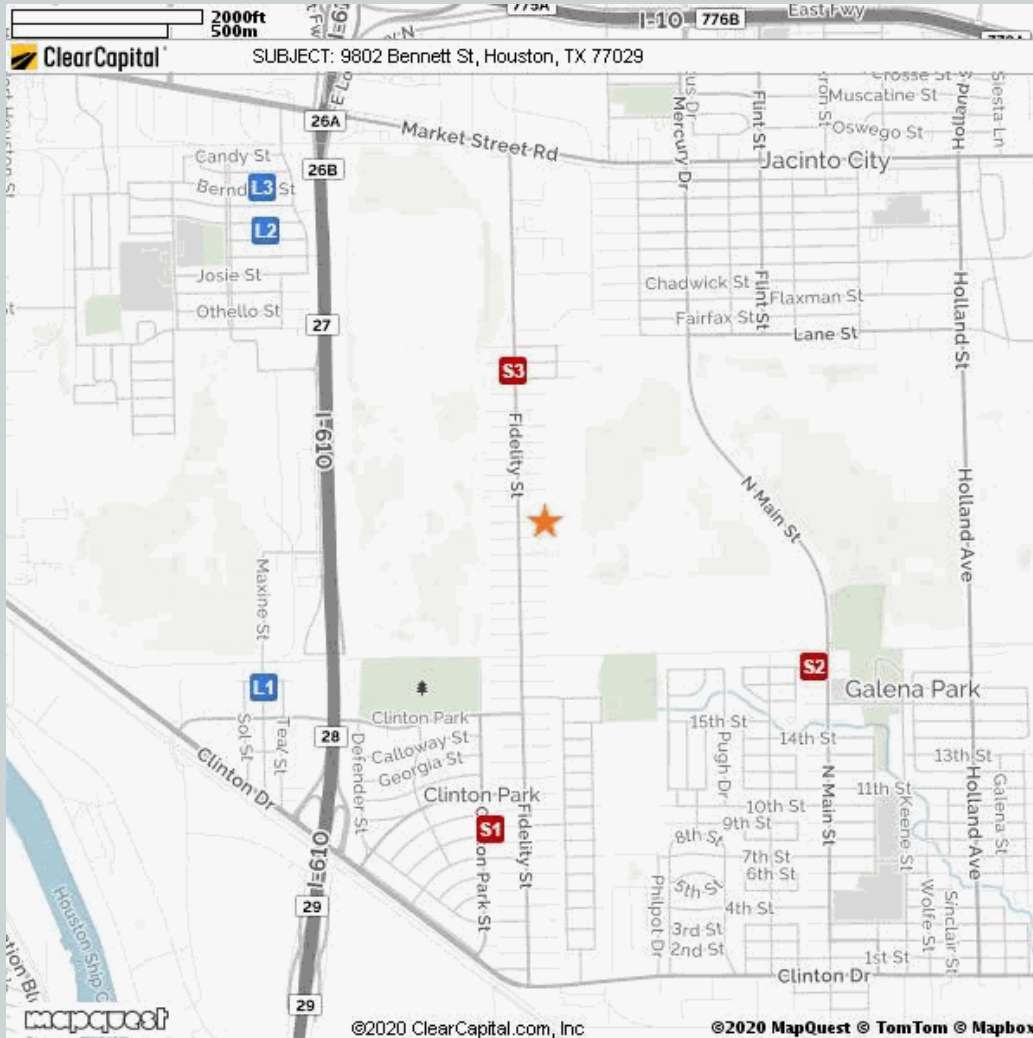
