**Listing 1** Adjustments: GLA Above: \$20.00 / sqft GLA Below: \$5.00 - Finished \$2.00 - Unfinished, Lot: .10 / sqft, Garage: \$1,500 / Stall, Bathroom: \$1,500, Condition: \$5,000 / Level, Age: \$500 / Ten Years, Location: \$5,000. This comp is slightly inferior due to the smaller above grade GLA and lack of a second Bathroom despite having a better location.

**Listing 2** Due to the lack of a garage and the smaller GLA both above and below grade makes this comp inferior.

**Listing 3** This comp is slightly superior due to the better location and the larger above grade GLA.

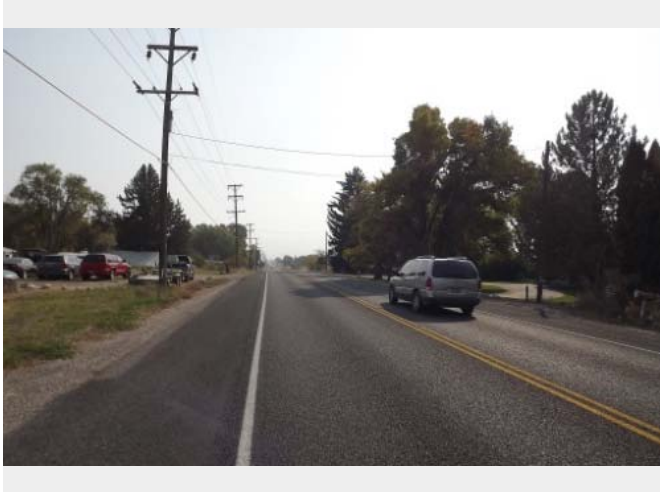

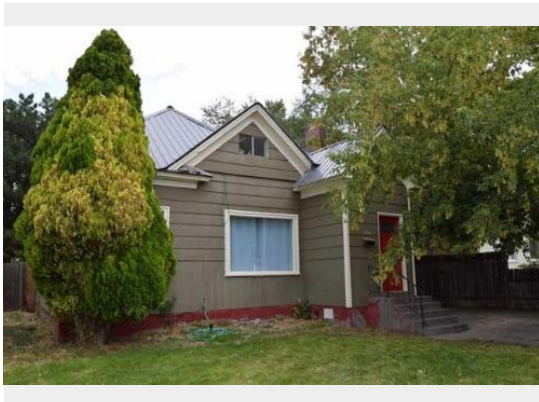

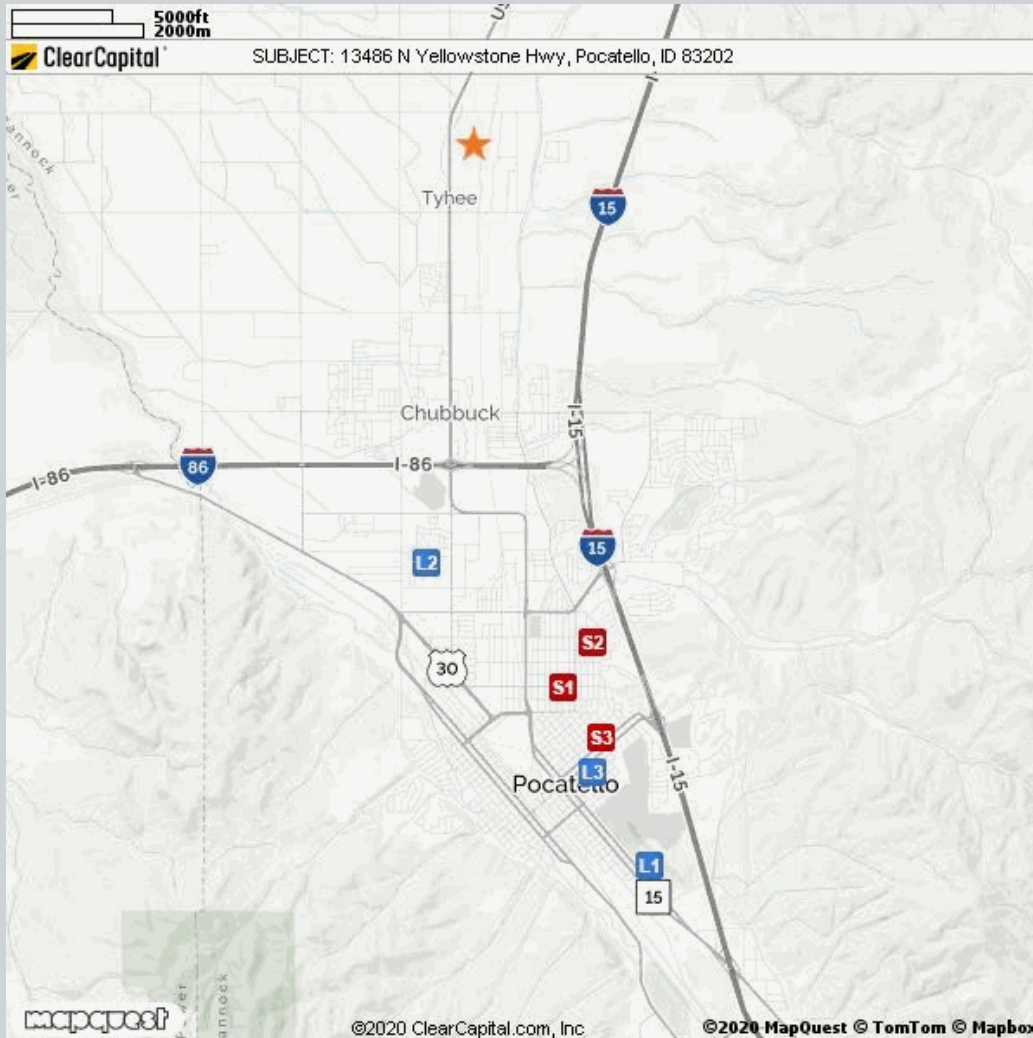
