It was necessary to exceed lot size guidelines for this comp. The subject's market area is made up of mixed older and newer comps therefore the guideline for comp age could not be met. Distance extended beyond 1 mile in order to find comps similar in GLA and condition.</p>		

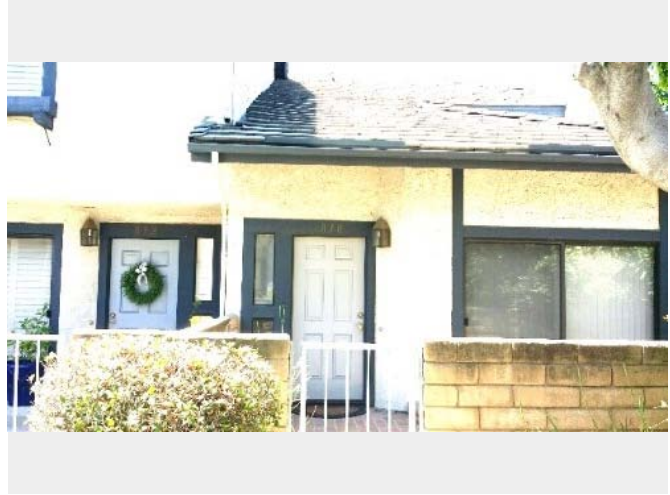
## Clear Capital Quality Assurance Comments Addendum
