<p>I reworked the bpo with better, more similar comps to the subject. This did lower my estimated subject value. There is still a price difference from what the subject sold for 6 months ago. It was purchased for all cash, and for \$35,000 less than list price. Also, there is a listing shortage in our area with increased demand, which has caused home prices to continue upward. These two factors account for the price difference in value presented in this report compared to the previous sale amount. I went back 6 months, out in distance 1 mile and was able to find comps which fit the bpo requirements. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps.</p>

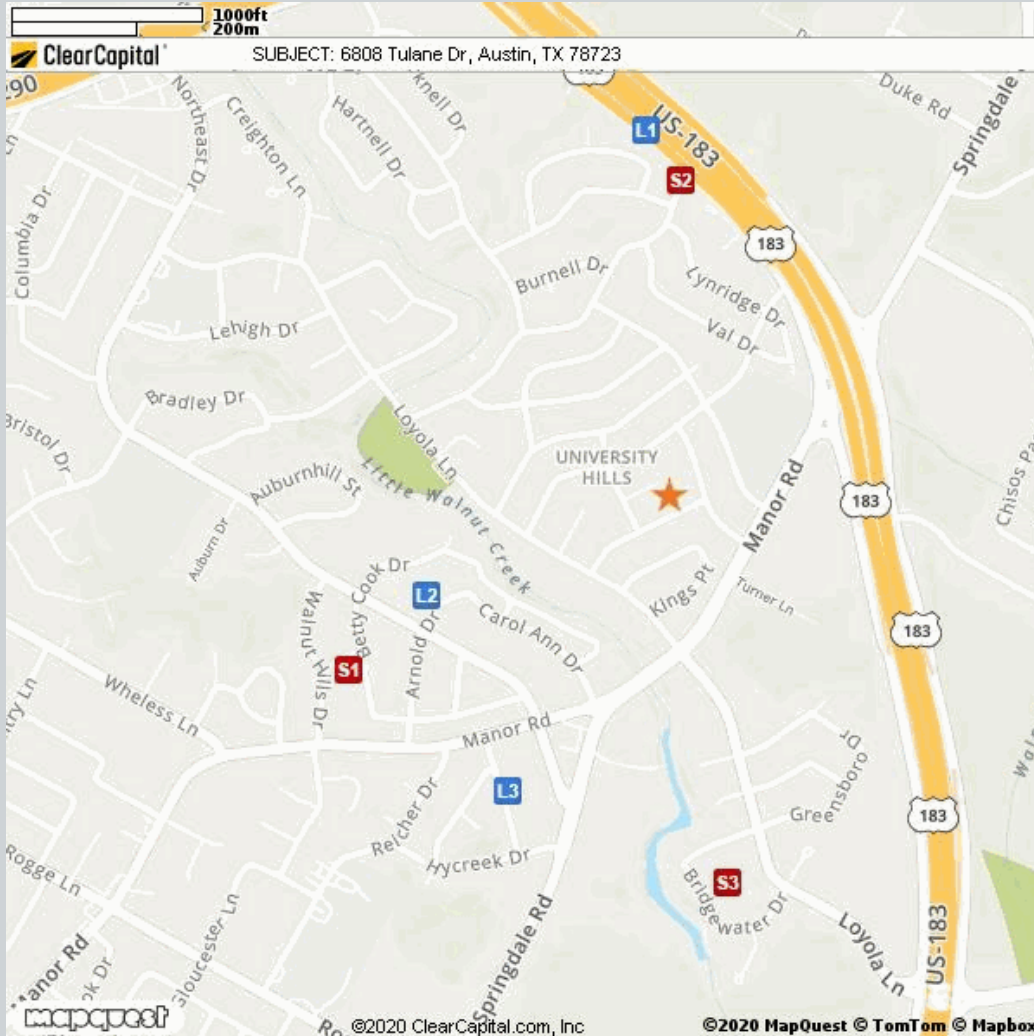
