It was necessary to search beyond 3 months time for sold comps as there were limited recent similar sales in this area. There are many rehabbed/remodeled homes in this market area, and they were excluded from the initial comp search. However, it was necessary to use two superior condition comps with adjustments due to the limited similar comps in this area. Market conditions and property values are improving within this area. 




