<p>The subject property is a single family home, which is in overall average condition on the exterior. When searching for comps, the distance searched was 1 Mile and the time searched was 12 Months time. It was necessary to search beyond 3 months time for sold comps as there were limited recent similar sales in this area. Since the subject is in average condition, emphasis was placed on using comps which were also in average condition. There are many rehabbed/remodeled homes in this market area, and they were excluded from the initial comp search. However, it was necessary to use two superior condition comps with adjustments due to the limited similar comps in this area. Market conditions and property values are improving within this area. The subject's bathroom count is unique for this area, and could not be bracketed. However, all of the sold comps were adjusted for this difference. The subject property is within 1/4 mile of a school, which will not negatively impact the subject's marketability. Comps within the subject's market area support a price which is slightly higher than the subject's last list price.</p>

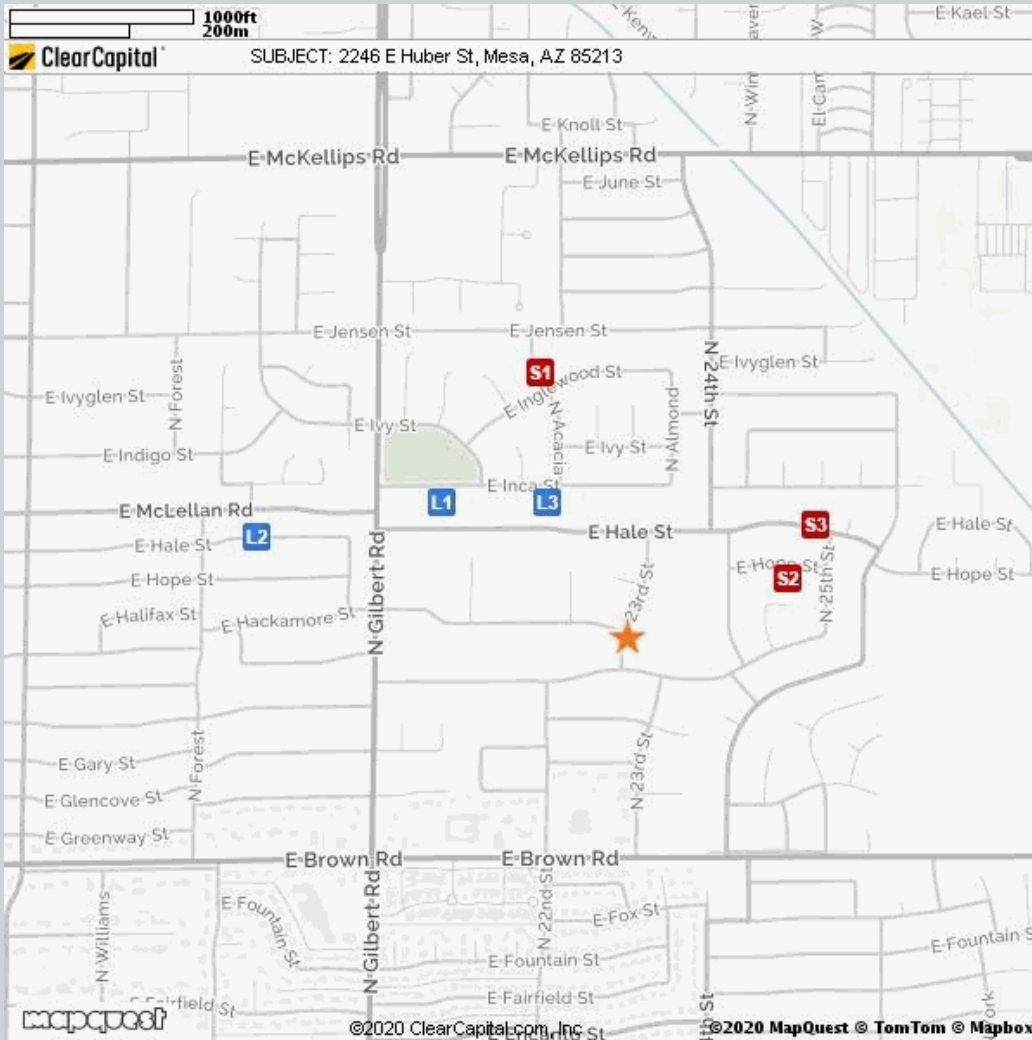
