





DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are located in the subject's general neighborhood and are recently closed. Comps 1 and 3 back to less traveled roads. Comps 1 and 3 per online photos are superior in condition and quality to the subject. Comps 2 and 3 are less than 100sf different therefore, no GLA adjustment was warranted. Comp 2 is similar in location and is noted to be slightly inferior in quality. Comp 3 per online photos appear to be slightly superior in condition and superior in quality to the subject. Most weight is given to comp 1 for its timeliness.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

ADDITIONAL COMMENTS (OPTIONAL)

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$1,210,000+/-appears to be considered reasonable as of 6/24/20. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.





This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Michael Gadams, a licensed real estate agent having completed the above referenced Property Inspection.
