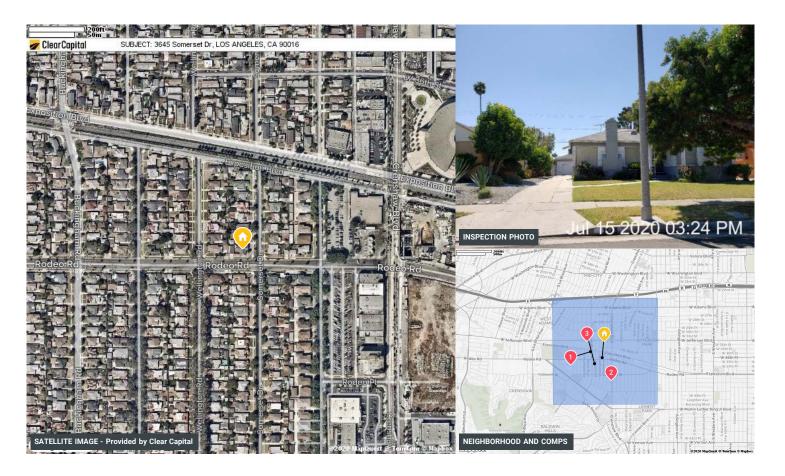

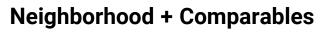

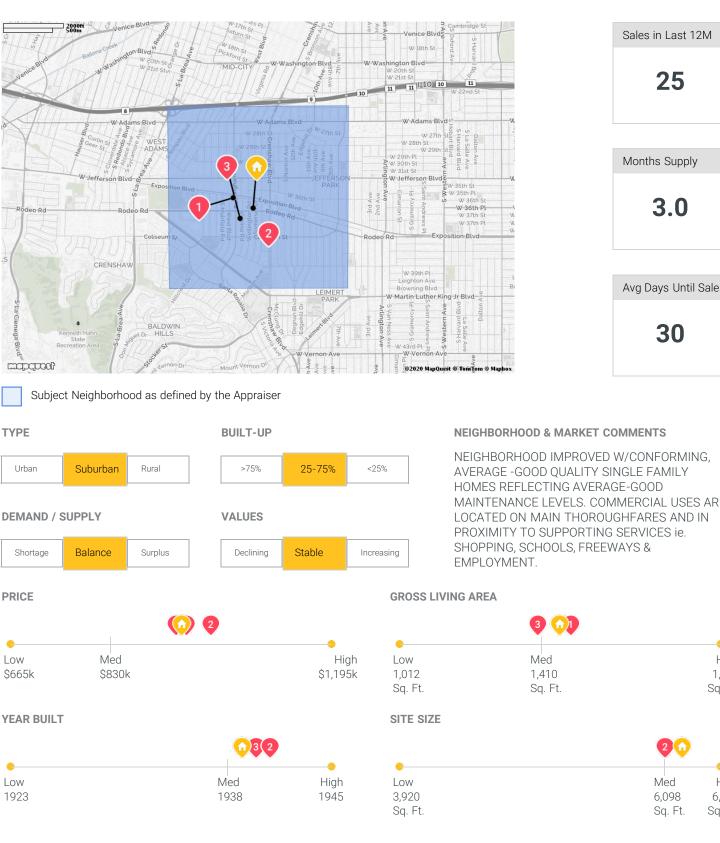

Scope of Work
