The search criteria was set to a one mile radius search (preferably using comps in the same subdivision when available) for comps within 5 years of age +/- and 20% sqft +/- . When this was not available the search radius was expanded. Please note no comps support the subjects current list price. ***Please note the value will differ drastically from my last report as the subject has been rehabbed to the top of the market.</p>

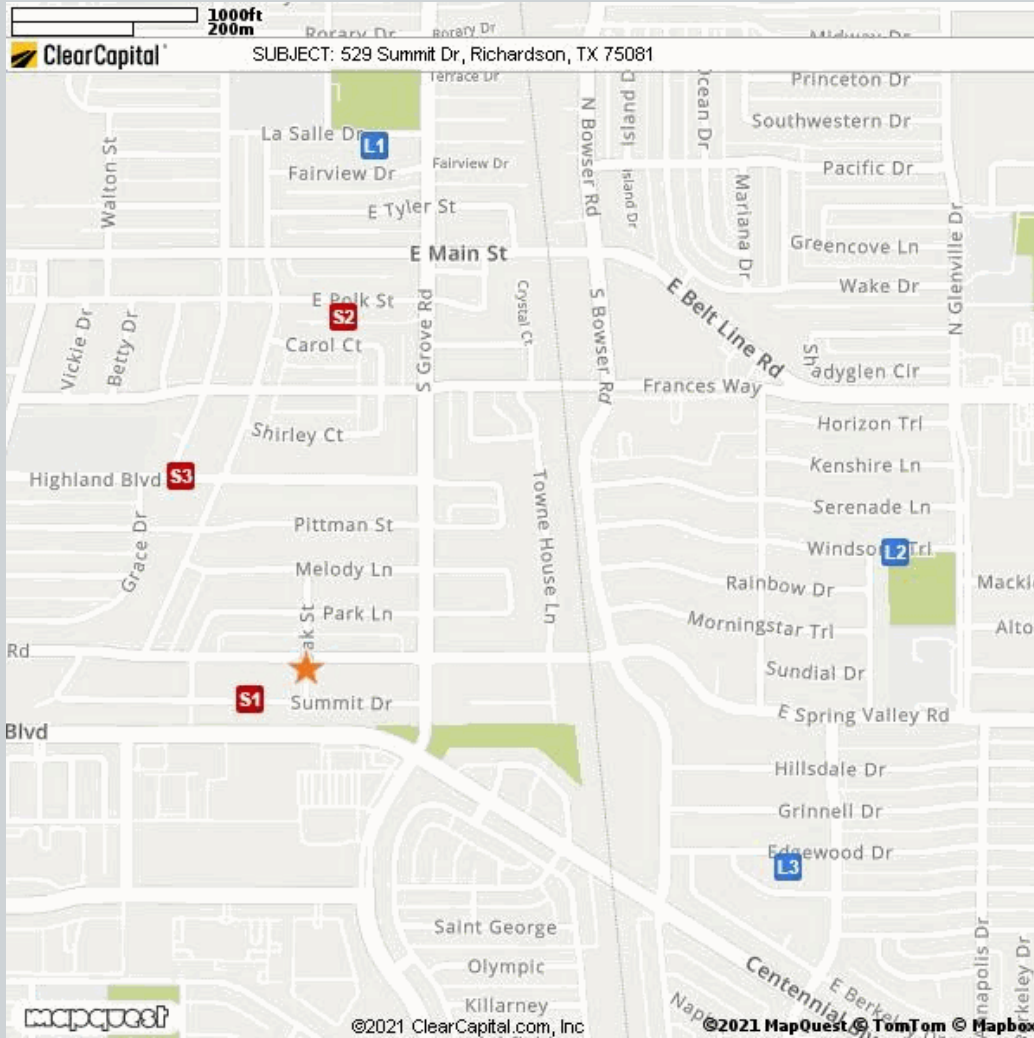
