Our market is currently stable- SFR increased 3.8% in sales price since this time last year, while condos/townhomes saw an increase of 9.7% in sales price. Inventory is around a 3 month supply. Distressed sales remain historically low, accounting for only 3% of sales. Cash sales account for about 22% of recent sales. Days on market have increased slightly-roughly 75% of homes sell within 60 days. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only-interior condition could dramatically affect the value of the property. Subject originally started out around suggested list price but is an REO so they dropped the price to have shorter days on market.


