- Sold 2** Sold comp two is also inferior despite having more land -1250 due to less overall GLA +3900 and year built +3K.
- Sold 3** Sold comp three is considered superior (-20K) as per listing remarks: "Updated kitchen w/island, granite counters, hickory cabinets, stainless appliances and more. Updated flooring, lighting, paint, sheetrock, hardware and trim throughout. Both bathrooms have been remodeled. A/C. Lots of potential on large lot w/sprinklers, raised beds, tool sheds and new backyard fencing." with more GLA -7930 on larger lot -3750 and better bed to bath ratio -2500; year built -1750.

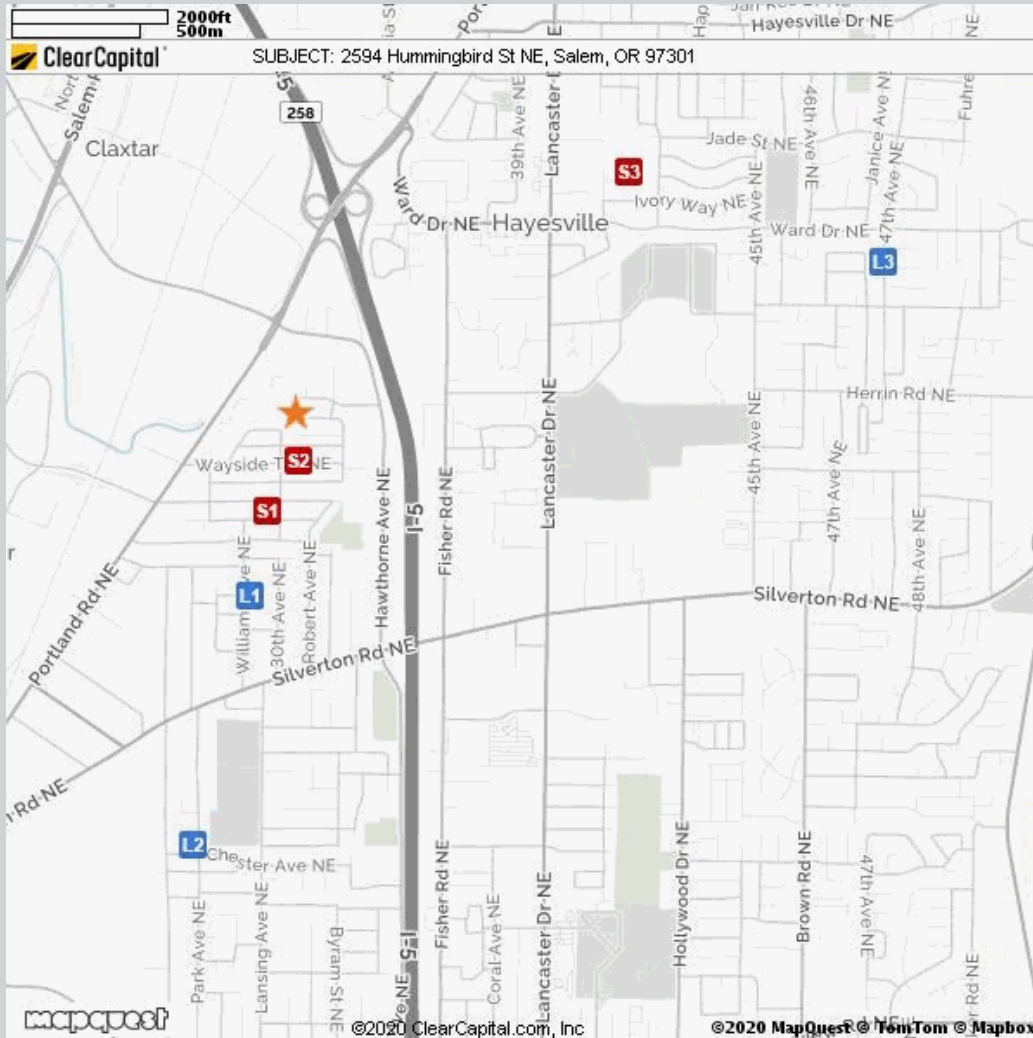
