Values have been adjusted as appropriate based on differences in condition or amenities. The value conclusion is based on an almost equal weighting of both the sold and active listings with greatest weight placed on those listings closest in condition and square footage. The sold comparable listings moved off the market within what is typical for this area which allowed the final pricing for the subject to be set aggressively to encourage the desired marketing period for a fair market value as requested in this report.</p>

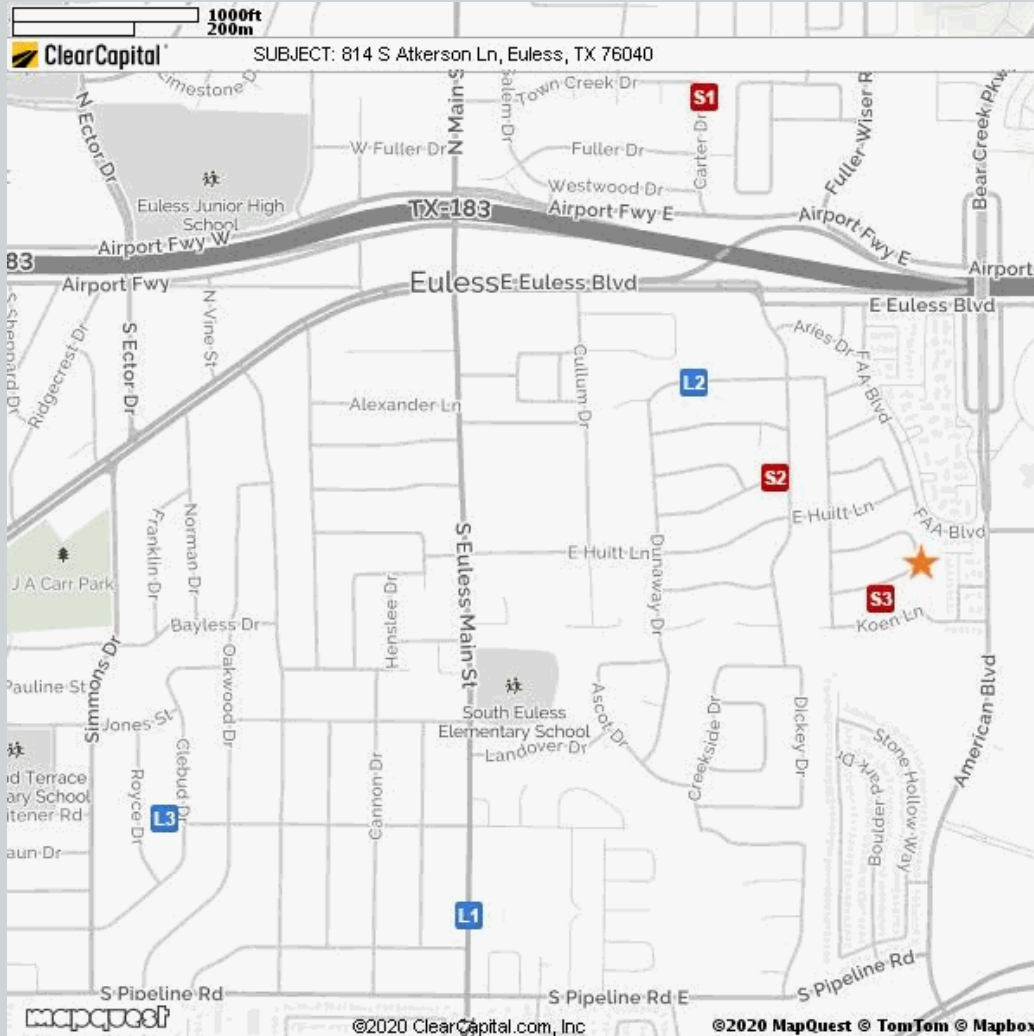
