

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

A one mile radius search of detached homes was used.

EXPLANATION OF ADJUSTMENTS

Comps selected were from the subject's immediate area and would be adjusted for differences in GLA and room count. Comp 1 would appear to be a model match and may have had inferior overall upgrades to the subject. Comp 2 had a similar appeal GLA and 2nd bath may be part of the lower level area. Comp 3 would adjust for superior ocean views, superior condition and superior GLA. All comps would appear to have similar "usable" lot area as the subject - no adjustment warranted.

ADDITIONAL COMMENTS (OPTIONAL)

09/05/2020: The quality rating for the subject (should be Q4) and bath count for comp 1 (should be 1 - model match to the subject) were corrected due to typos. The subject has an effective lot area of .09 acre and deemed to have a "similar" usable lot area and the comps selected. Please view aerial images of the subject lot for additional confirmation of this item.

The purpose of this Appraisal Report is to determine an and the opinion of the market value for the subject property, at which it could sell in a typical exposure time for the area, considering current market conditions, the condition of the subject and necessary repairs.

SCOPE OF WORK:

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Doug Gillies, a licensed real estate agent having completed the above referenced Property Inspection.
