Subject is a single family home with 636 Sq.ft. Since there were limited comparable available within subject's market neighborhood, it was necessary to use a sold comparable with a sale date beyond 3 months from the date of this report. Due to limited comparables, need to exceed sold date up to 6 months, bed/bath count, lot size and year built guidelines. To stay in closer proximity need to use good condition comparable. Subject is located near busy road, highway, school, park, airport, railroad and commercial amenities. Due to limited comparable from same location, it was necessary to use comparables from across the RR track. However, this wont affect the market value. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS2 and LC1 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. Subject and comparables garage count is verified using MLS.




