In delivering final valuation, most weight has been placed on CS2 and LC1 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. 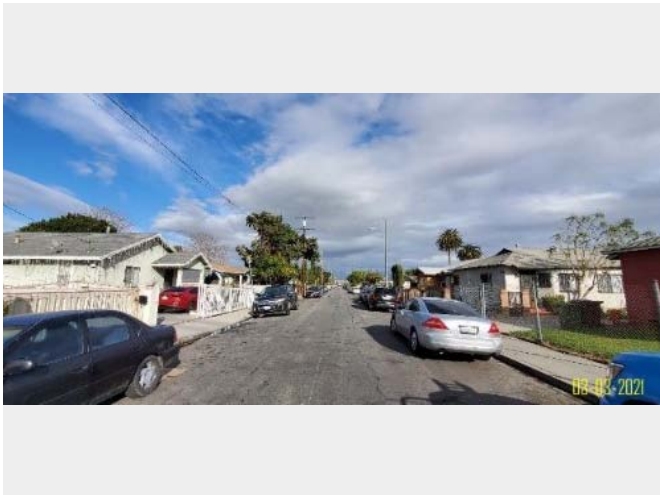

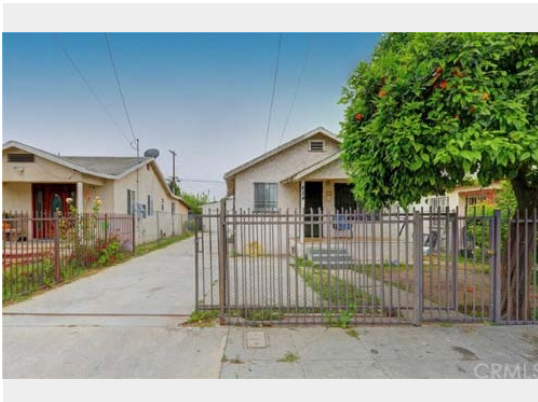

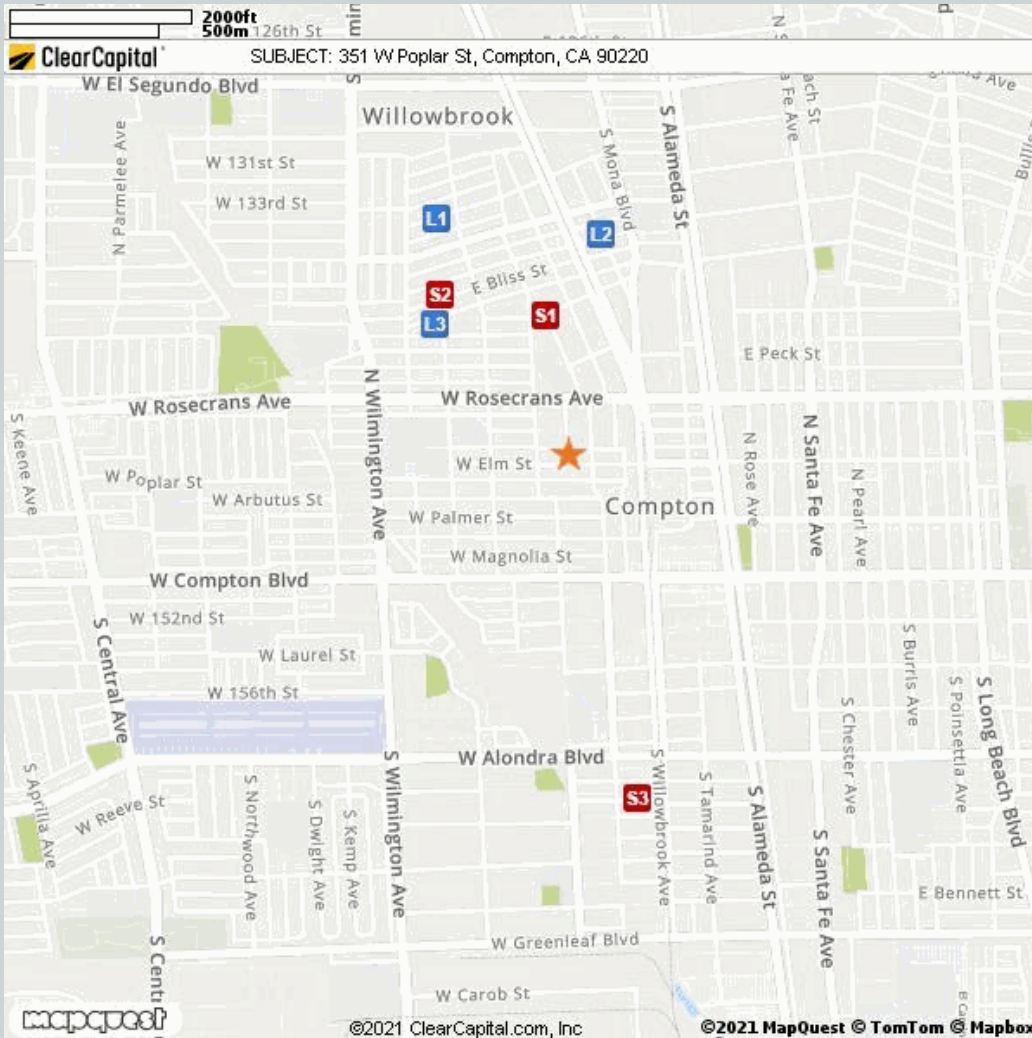
