Listing 3 L3 is inferior in lot size, bathroom type, GLA, and age. L3 is comparable in location, garage stalls, and appeal. Because of lack of comparable listings search radius was expanded to 1.25 miles.

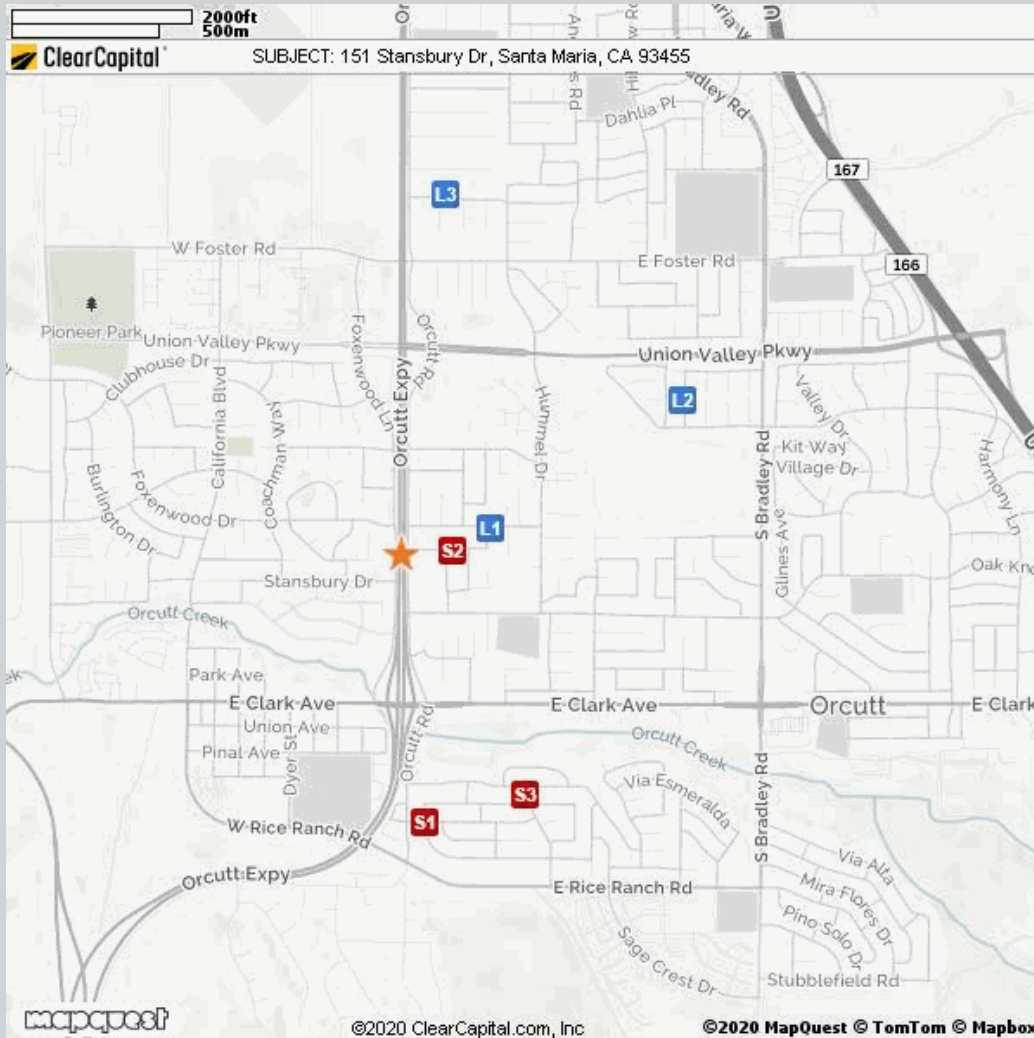
