<p>To locate comparables, the MLS was searched for comps by the following search parameters: GLA range of 1698 to 2546 square feet, within 1 mile radius, and 12 months time for sold comps. Since there were limited comparable available within subject's market neighborhood, it was necessary to use a sold comparable with a sale date beyond 3 months from the date of this report. Due to limited comparables, forced to exceed bed count and closed date up to 12 months. In order to support the subject's GLA, it was necessary to use comparable that differed from the subject's style.. Subject is located near busy road, park, school, highway, worship area and commercial amenities. Comparables are also from similar location and it support subject value and marketability. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. Subject and comparable garage count is verified using MLS.</p>

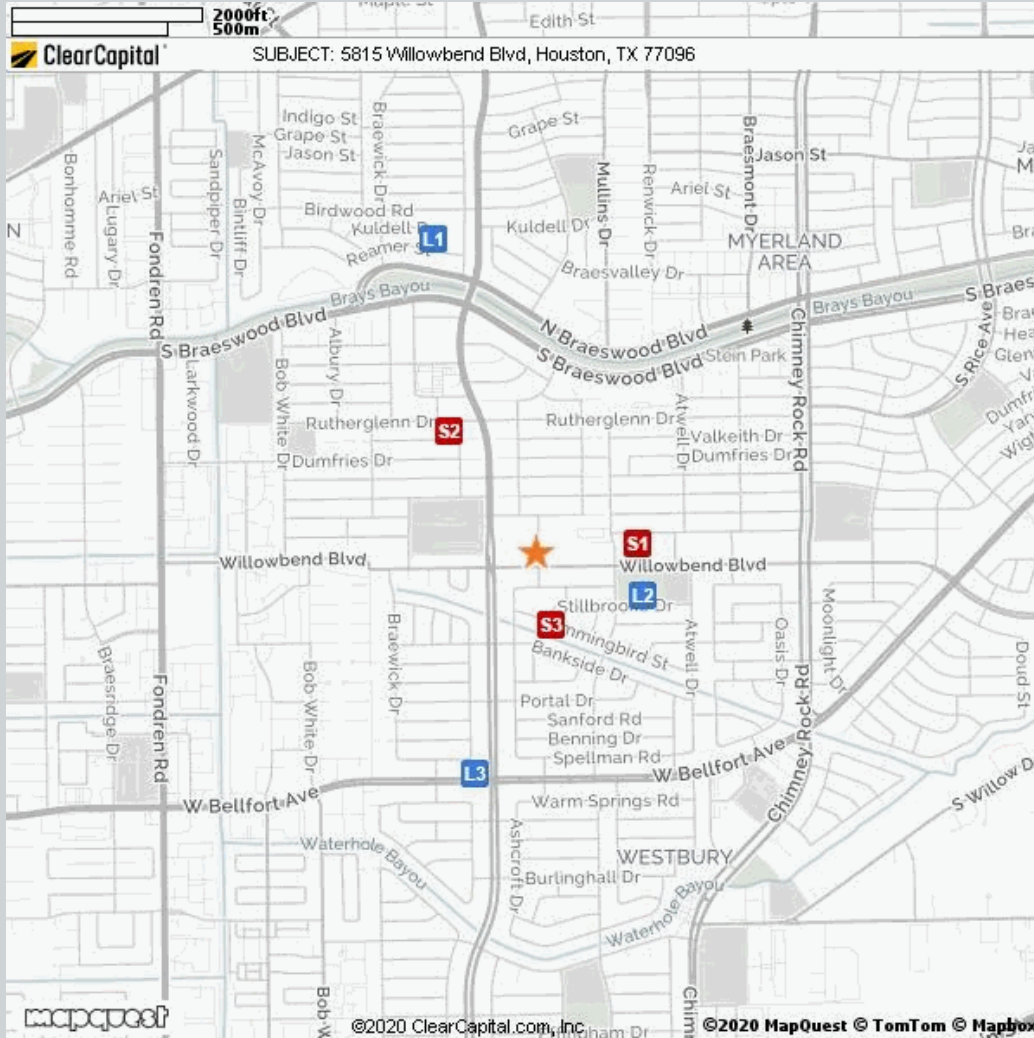
