

Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. Comps 1 and 2 appear to be on similar size sites and all comps are less than 100sf different in GLA therefore, no adjustment is warranted. Comp 1 superior in condition and quality while comp 2 is superior in condition. Comp 3 is on a larger site and appears to be similar in quality, but is inferior in condition. Most weight is given to comp 3 for its similarity and timeliness.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

ADDITIONAL COMMENTS (OPTIONAL)

Online comments note the subject is a "fixer". No comp in similar condition was found. The appraiser chose the best comps available.

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$525k +/-appears to be considered reasonable as of 9/25/20. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.




