**Comments Regarding Pricing Strategy** 

The subject property is a single family home, which is in overall good condition on the exterior. The subject's attached current MLS Listing indicates that the subject is in good condition and the inteiror has been updated/remodeled. Therefore, all comps used in this report are in good condition. The subject's roof appears to need a repair, as outlined in this report. The subject's location was confimed via Parcel Map. The distance searched for similar comps was 1.25 Miles and the time searched was 12 Months time. Comps were searched for slightly beyond 1 Mile to locate properties similar in GLA and other attributes. It was necessary to search beyond 3 months time for sold comps as there were limited recent similar sales in this area. The GLA Tolerance searched for comps was +/- 20% of the subject's GLA. Market conditions and property values are improving within this area due to very strong demand and limited inventory of homes for sale. The subject is located within 500 Feet of Commercial/Industrial Property. It was not possible to locate a similar comp with the same influence. However, all of the sold comps were adjusted for this difference. The value variance between comps is larger than typical, but was necessary due to limited similar comps in this area. The subject's price has been bracketed within the range of comp values and both the sold and list comps were considered since the subject is located in a rapidly improving market area. 
