It is inferior in no pool \$22,000 but is superior in square footage adjusted @ \$60/square foot (\$5,600) and seller paid concessions (\$10,000). Under contract in 1 day from price reduction.

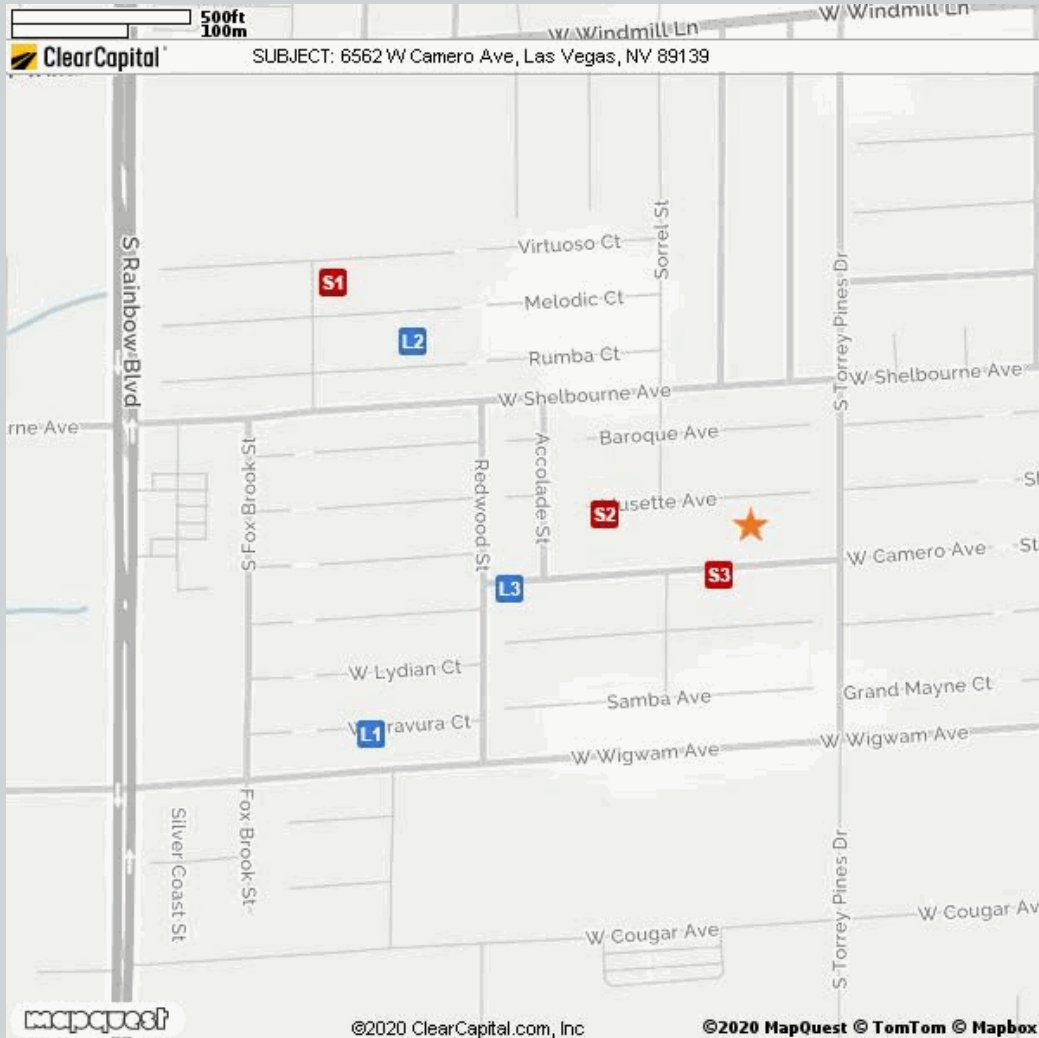
