The properties used are the best possible currently available comps within 0.99 miles. The adjustments are sufficient for this area to account for the differences in the comparables to accurately reflect the current market prices of the subject.</p>

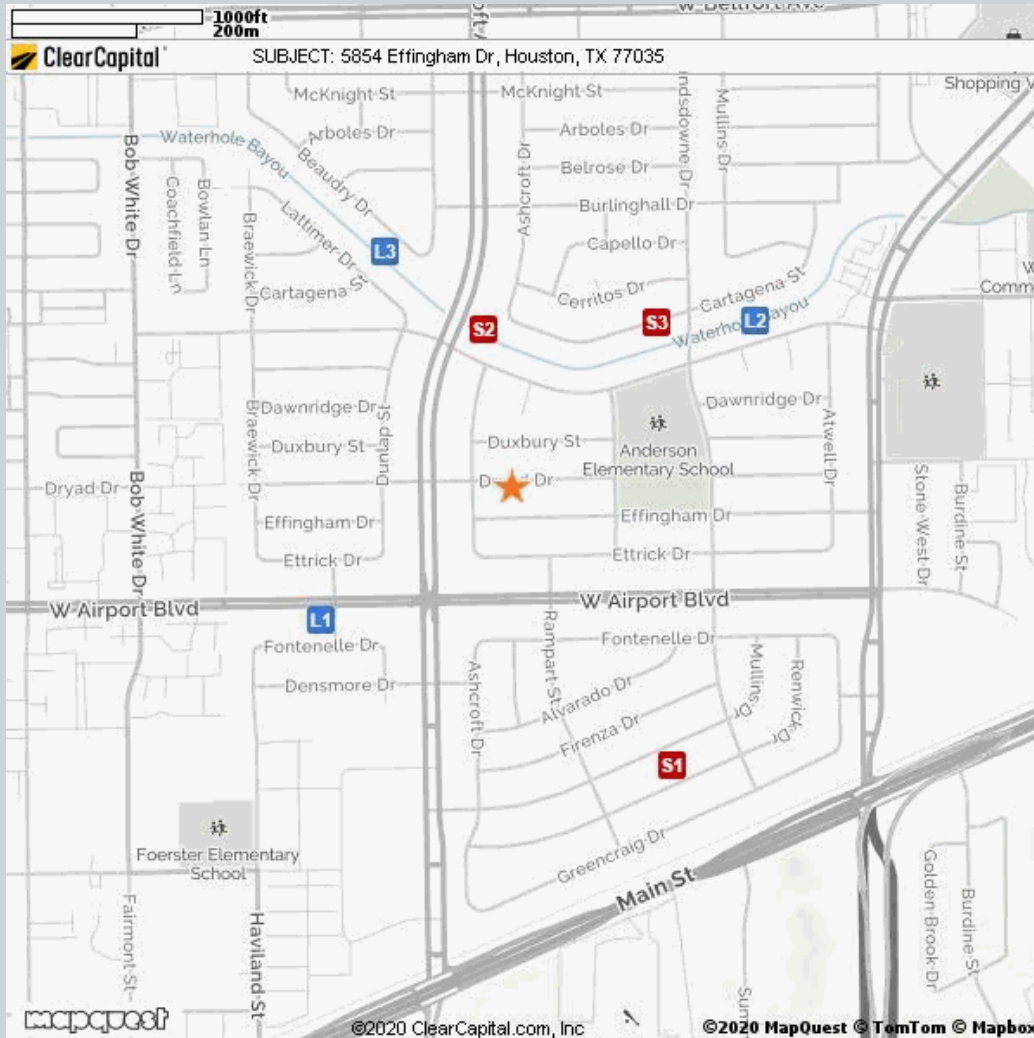
