Clear Capital Quality Assurance Comments Addendum

Reviewer's Notes The broker's as-is conclusion is supported by the comparable data. It is noted the current as-is conclusion is higher than the prior; however, the Clear Capital Home Data Index indicate the market has increased by + 15.7% over the past 12 months. The prior also put majority weight of value into S2, inferior in GLA - understating value. The current report also uses more proximate comps than the prior - better valuing the current neighborhood market.

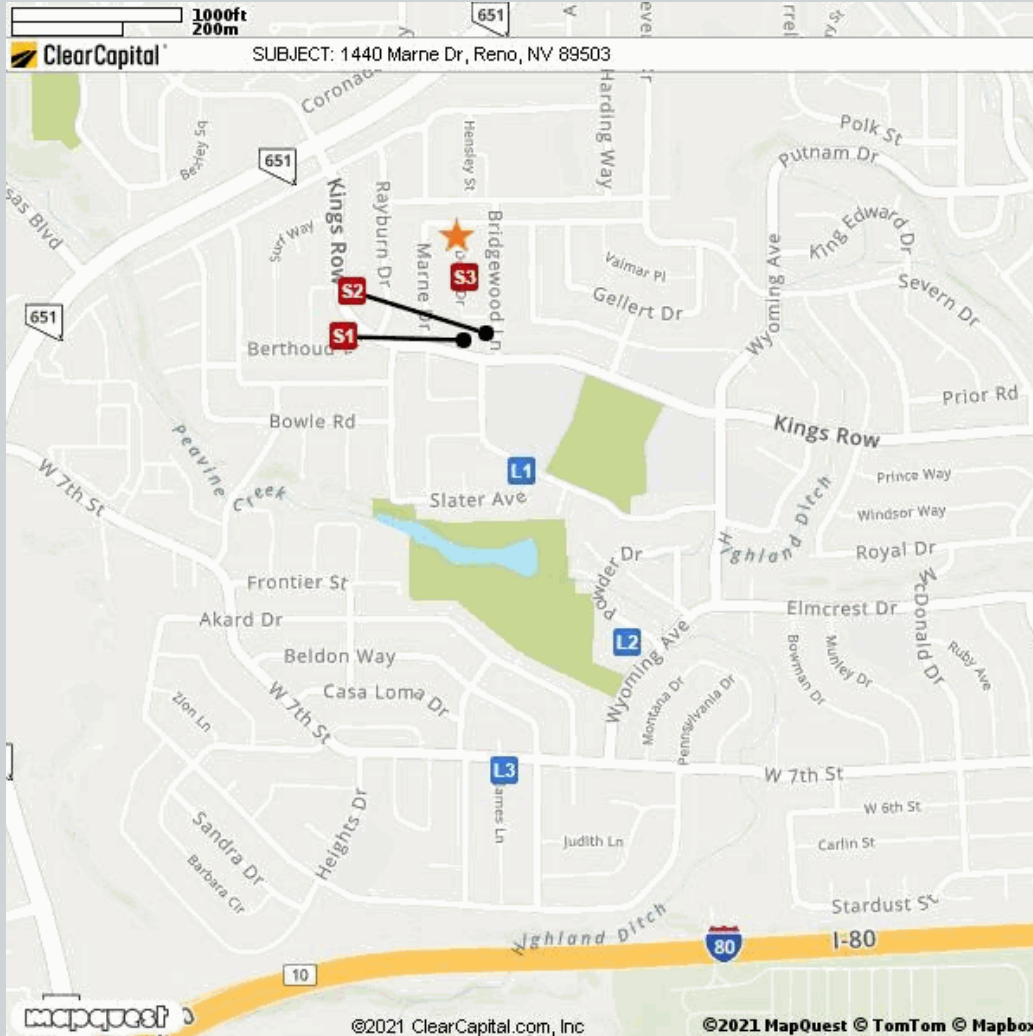
