**Listing 1** Listing 1 is superior in age and GLA, and garage. Similar location. Due to a complete lack of similar age, GLA and condition comps this superior comp is used. Superior overall. Subject area.

**Listing 2** Listing 2 is similar in GLA, location and lot size. Due to a complete lack of similar age comps this superior comp is used. Similar condition that brackets subject condition. Distance was expanded to 3 miles to find additional similar comps that bracket criteria.

**Listing 3** Listing 3 is more similar in age, but still superior. Similar average condition. Smaller GLA. This smaller GLA home is used because it is the only comp that brackets GLA. Due to a complete lack of similar age, GLA and condition comps this more distant comp and newer comp is used. This is the most similar comp found due to similar age and GLA. However it is the least proximate. Distance was expanded to 3 miles to find additional similar comps that bracket criteria.

- Sold 2** Sold 2 is similar in GLA -\$4300, -\$9300 age, similar condition. 0cc. Similar location and GLA. This comp is similar overall. -\$2000 bedroom, - \$1000 half bath.
- Sold 3** Sold 3 is similar in GLA, and location. Inferior age \$3600 age. This comp is used to bracket age for the listings and sales. It doesn't quite bracket GLA, but it comes close. Similar condition -\$32,000 acreage. -\$2000 bedroom, - \$2000 bath. -\$1000 cc.

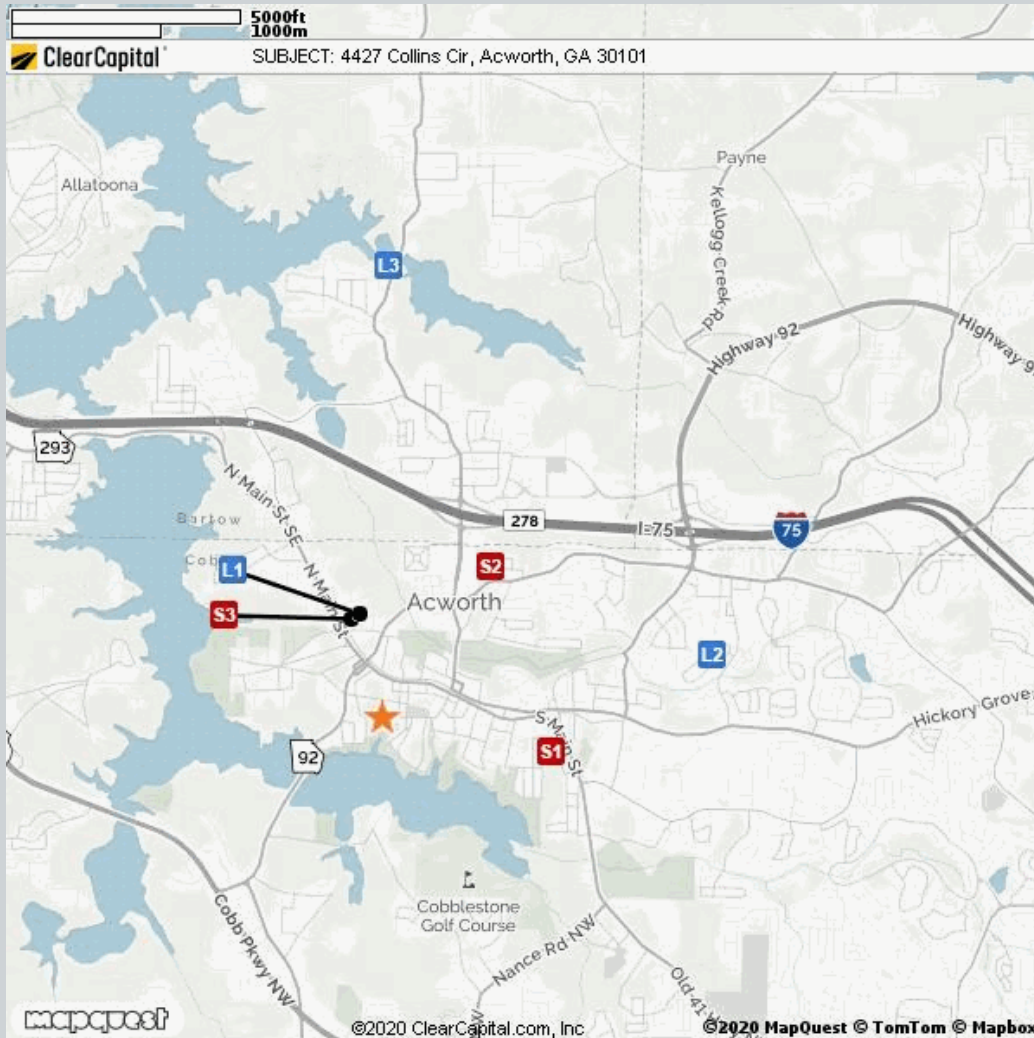
