Our market is increasing- SFR increased 10.8% in sales price since this time last year, while condos/townhomes saw an increase of 8.9% in sales price. Inventory sits at a 1.5 month supply. Distressed sales remain historically low, accounting for only 0.9% of sales. Cash sales account for about 19% of recent sales. 


