Subject is located near busy road, highway, school, park, water bdoies,, railroad and commercial amenities. Due to limited comparable from same location, it was necessary to use comparables from across the busy road. However, this won't affect the market value. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS3 and LC2 as they are most similar to subject condition and overall structure. Subject details are taken from tax record. 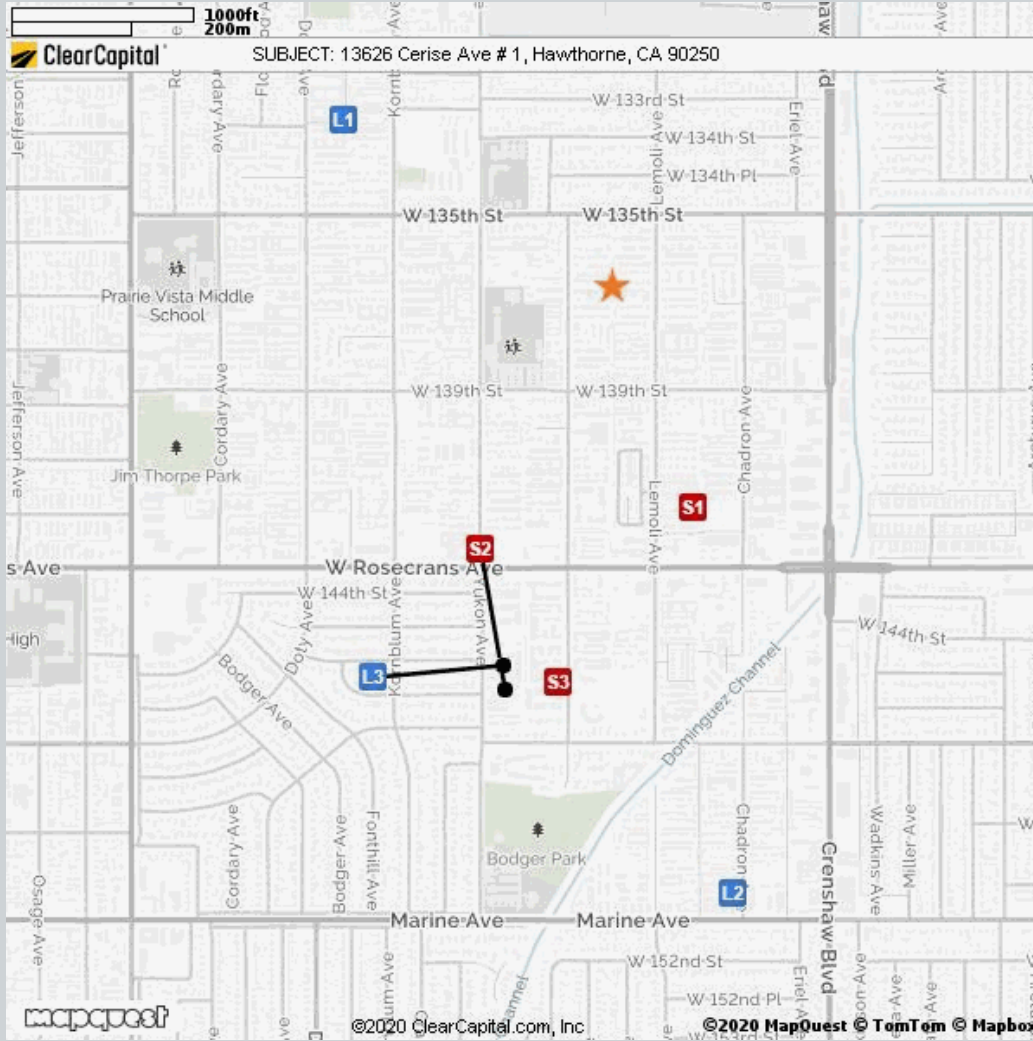
