<p>The search parameters were expanded to a +or- 20% GLA range, no age range, 12 month COE date range, & a 1.5 mile radius. I was able to locate 4 of the 6 comparable properties, including 2 of the sales, within 0.46 miles of the subject. All of the comparable sales have a DOM of less than 90 days & sold #1 has a COE date over 6 months old. They have been adjusted to reflect the increasing market. In my opinion the 6 horses properties used are the tightest bracketed price grouping, & the best available within the expanded search parameters to determine the subject's current market value.</p>

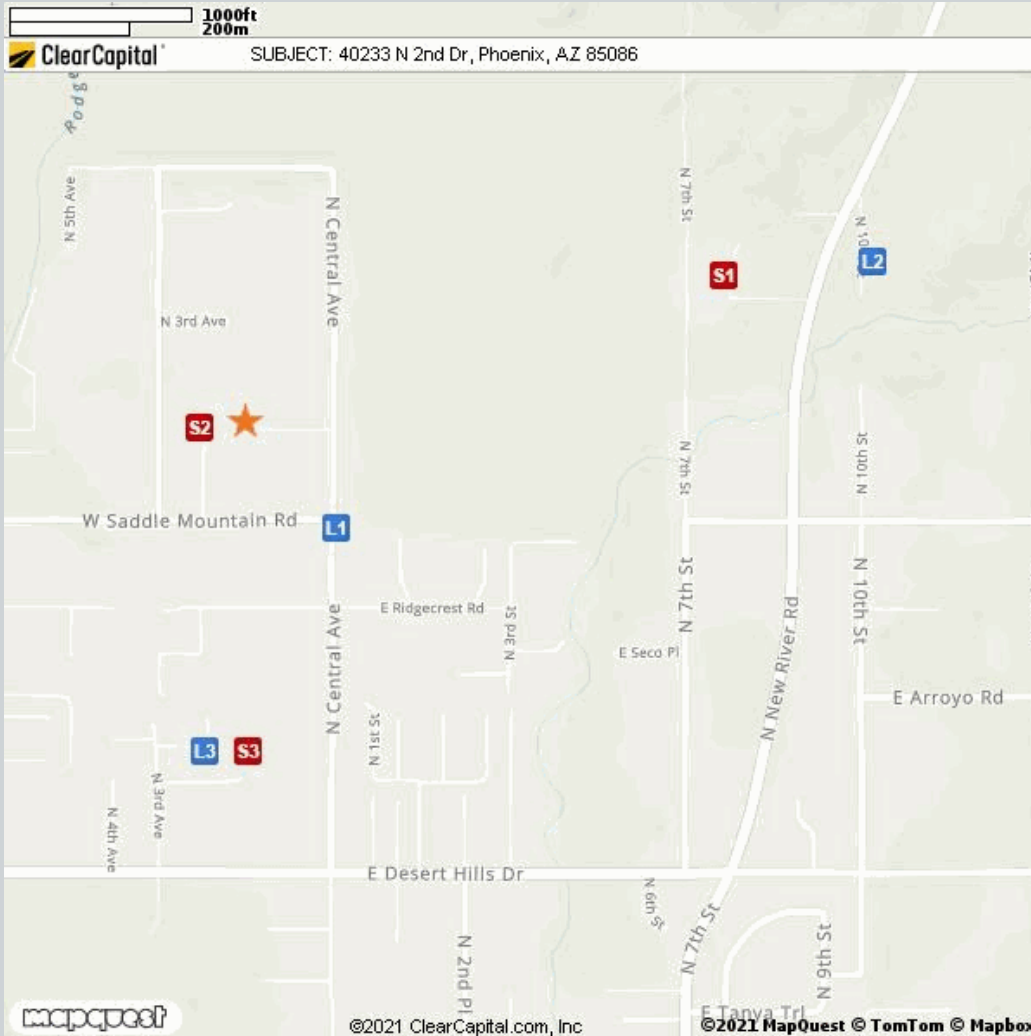
