<p>Our market is increasing- SFR increased 12.4% in sales price since this time last year, while condos/townhomes saw an increase of 14.1% in sales price. Inventory sits at just over a month supply. Distressed sales remain historically low, accounting for only 0.8% of sales. Cash sales account for about 19% of recent sales. Days on market have increased slightly- roughly 85% of homes sell within 60 days. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only- interior condition could dramatically affect the value of the property.</p>		

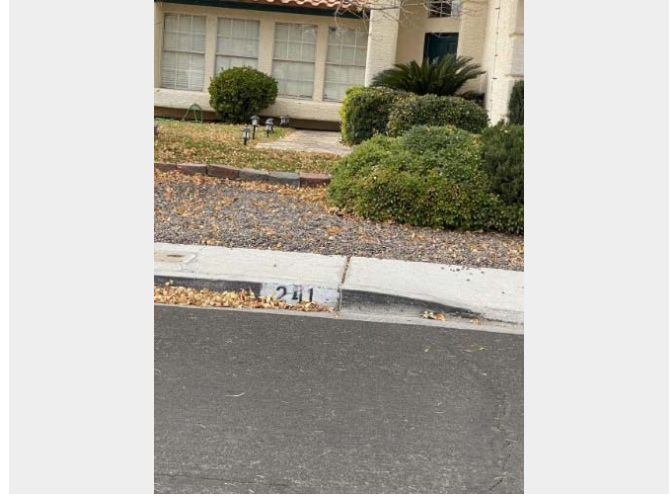

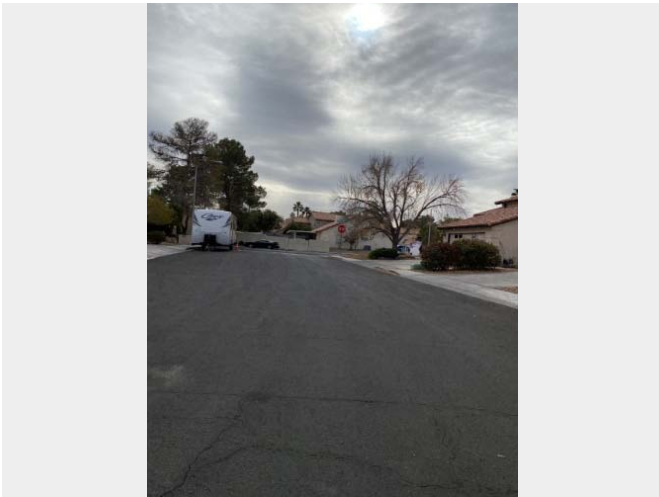

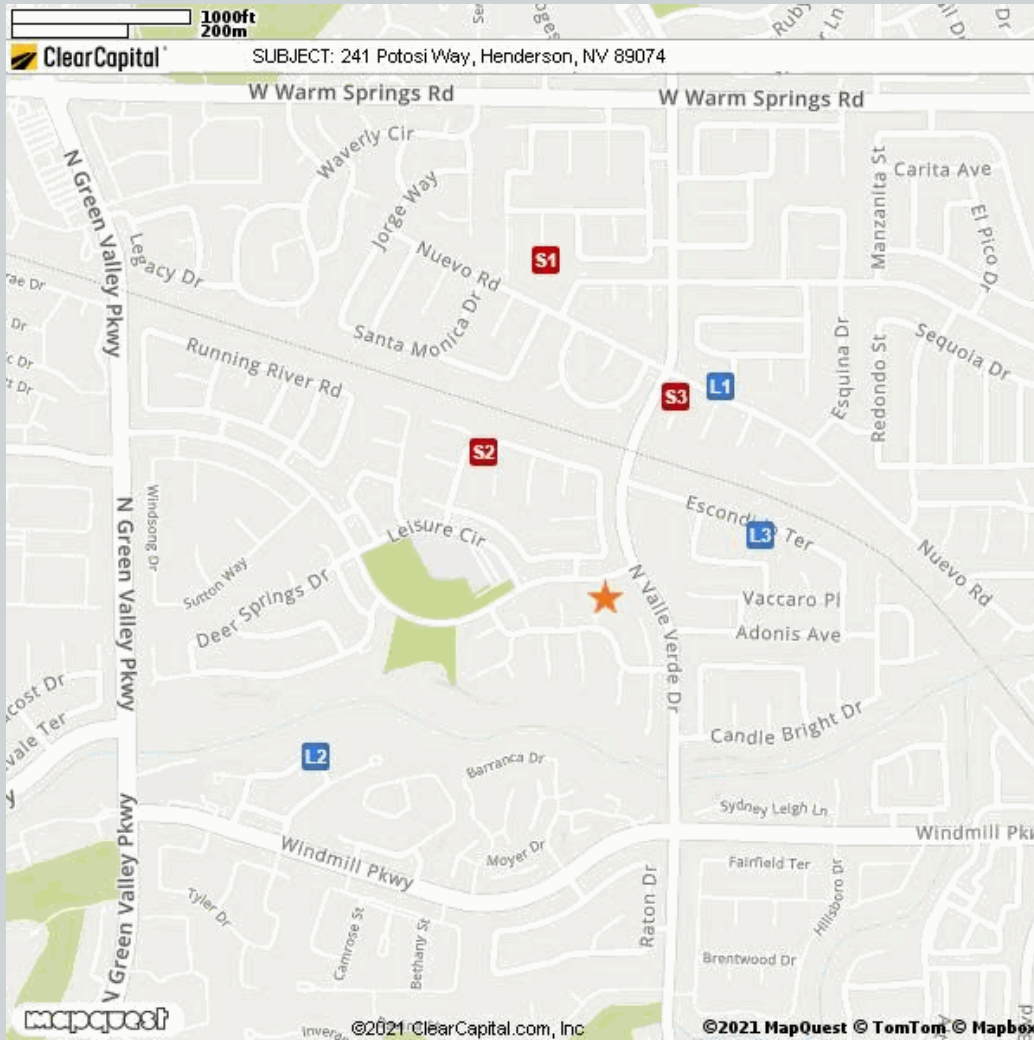
