

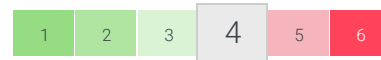

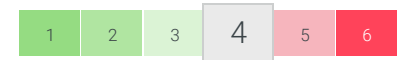

Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. All comps are less than 100sf different in GLA therefore, no adjustment is warranted. Comps 1 and 3 appear to be model matches. Per online photos comp 1 had recent improvements and is slightly superior in quality. Comps 2 and 3 appear to be inferior in condition/quality. While comp 4 appears to be similar in condition and quality to the subject. Most weight is given to comp 1 for their similarity and timeliness.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

ADDITIONAL COMMENTS (OPTIONAL)

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$1,100,000 +/- appears to be considered reasonable as of 1/14/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.
