Pricing suggestion came about from analyzing the most current comps which are located as close to subject as possible and are as close as feasible in square footage, location, condition, style and acreage with subject property. I have searched a distance up to 0.5 mile, GLA +/- 20% sqft, lot size +/-30% sq ft, age +/- 20% yrs and up to 3 months in time. This was expanded to up to 12 months in time, bed bath count, gla, age, style, proximity upto 1 miles due to lack of similar homes. To obtain values in similar location of the subject it was necessary to use dissimilar bed/bath count comps. Due to the lack of comps it was necessary to take a comp with variance in view. Subject is located near freeway/highway, waterbody, park, commercial however it doesnot have any impact on the value. Due to lack of comps in the subject's same side it was necessary to exceed major boundaries such as rivers, rail road tracks, major roads, highways, freeways, etc.






