However, currently there is upward value pressure from similar listings. Sold adjusted values are fairly consistent. Final value is weighed most heavily on Sold Comp 2 as it is proximate, appears to be most similar and is a recent sale. Due to the lack of similar sold comps, I had to use sold comps that were more than 3 months old.</p>
