The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps. The search distance was expanded beyond 1 mile due to lack of similar comps in the area. The search was expanded into similar neighborhoods to find properties similar in GLA. LThis is a low inventory market and most weight was given to most recent sold comps when determining the subjects fair market value.</p>

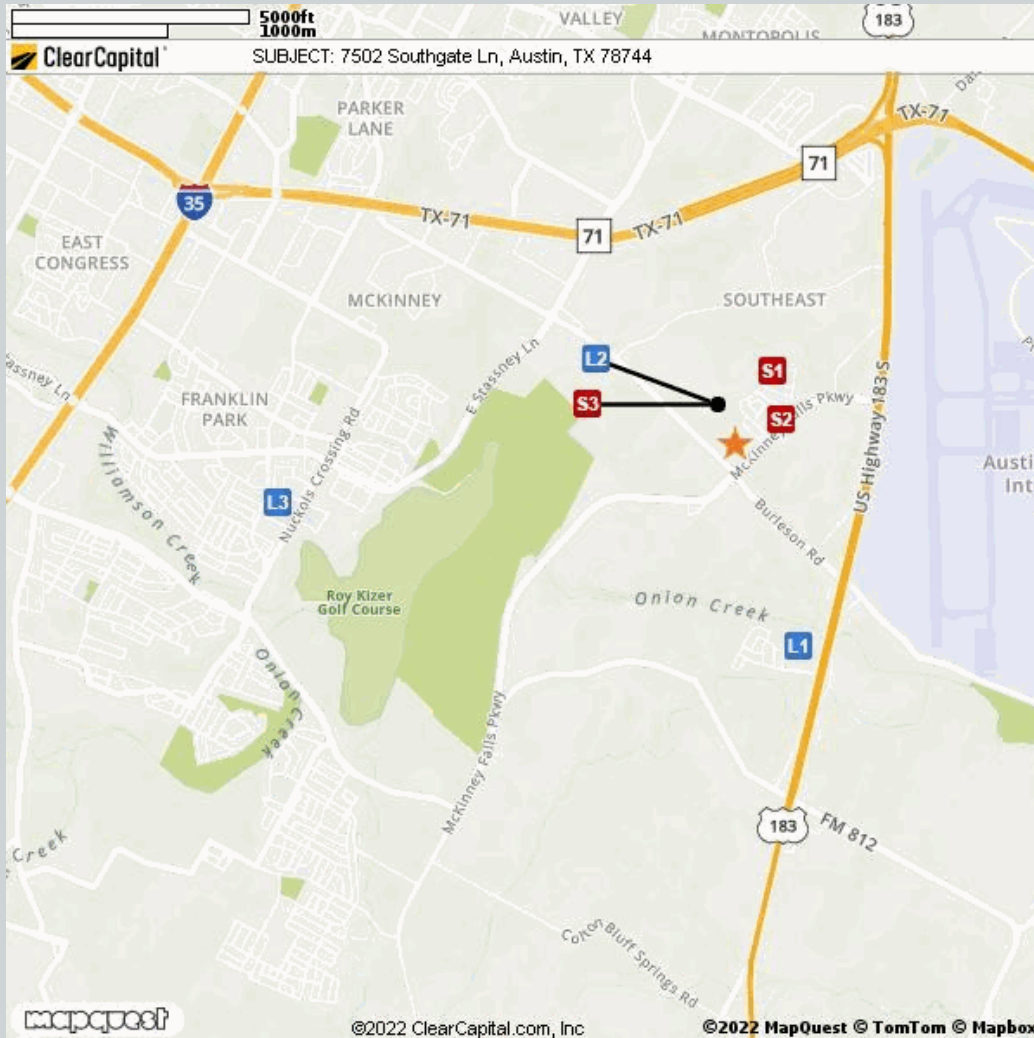
