### Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. Comps 2 - 4 were adjusted for their location on a less traveled road. Comps 1 and 3 are less than 100sf different in GLA therefore, no adjustment is warranted. An additional GLA adjustment was given for comp 2 as the total was too larger for the GLA box. Per online photos comps 1, 2, and 4 appear to be superior in condition and quality. Comp 3 is similar in condition. Most weight is given to comp 1 for its proximity.

**EXPLANATION OF ADJUSTMENTS** 

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

### Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$1,100,000 +/-appears to be considered reasonable as of 2/19/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.







Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records.
